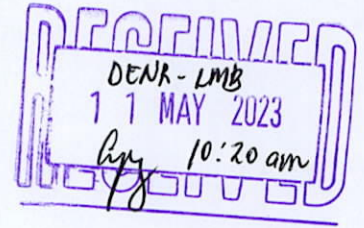


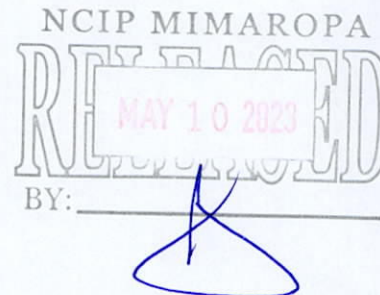

This office has an approved project CY 2023, "Conversion/Delineation of CADC-124 into CADT of the Mangyan Alangan ICC - Stage 2. Social Preparation II and Stage 3. Survey and Verification of Survey returns" in the Municipalities of Baco, Naujan, San Teodoro, Province of Oriental Mindoro. The Mangyan Reservations within the Mangyan Alangan Ancestral Domain Claim are for projection in the ancestral domain map.

In this regard, may we respectfully request a copy of the survey plan of the Mangyan Reservation Proclamation No. 41 dated February 26, 1936, with an area of one hundred eighty-eight (188) hectares.

Further, may we ask about the Proposed Mangyan Reservation Status in Pagturian and Mabaron, San Teodoro, and Puerto Galera, Oriental Mindoro, with an area of four hundred fifty (450) hectares.

Attached herewith is a copy of the list of Mangyan Reservations and Proposed Mangyan Reservations from the Bureau of Lands, Land District No. 9, Calapan, Oriental Mindoro.
