RESOLUTION NO. 25

RESOLUTION PROVIDING THE IMPLEMENTING GUIDELINES OF RESOLUTION 17 AS ENACTED BY THE INTER-AGENCY COMMITTEE ON 2022

Whereas, Pursuant to the provisions of the Resolution No. 17, in order to restore the natural state and flow of the river and taking into consideration the essential role played by constant sand replenishment, all dredging activities shall initially be conducted at the delta of heavily silted channels thereby providing more depth for passage of dredging vessels to implement flood control measures within the River Dredging Zone.

- 1. The River Delta Clearing and Shoreline Enhancement Plan and the attendant Work Plan is an integral part of the restoration and rehabilitation of the subject rivers. It shall provide for wider margins in consideration of the active and powerful hydrodynamics that impact the work area. It should include the following parameters:
 - a) The planned depth and width of the river delta to clear;
 - b) The maximum distance to the end of the clearing:
 - c) The timeline and duration of the activities;
 - d) The bathymetric and marine surveys of the immediate environment;
 - e) The location of marine protected areas within the vicinity, if any:
 - f) The quantity of the materials to be removed.
- 2. The work plan for the delta clearing will indicate the following:
 - a) The methodology
 - b) The equipment to be utilized and their specifications
- 3. The Plans, as submitted by the proponents will be reviewed and endorsed by the Provincial Engineering Office to the PGO, the Project Owner, who in turn will submit the same to the IAC with specific attention to the DPWH Regional Office 4B to determine whether it is congruent to the objectives of the river restoration project.
- 4. The Reviewed Plan, if found to be congruent to the river restoration project, will be endorsed to the IAC for approval by the Committee.
- 5. The Approved Plan will be endorsed to the Environment Management Bureau Regional Office 4B for issuance of the Environmental Compliance Certificate.

- 6. The Governor will issue the Notice to Proceed (NTP) for the Approved Delta Clearing and Shoreline Enhancement Plan, upon payment of the Extraction Taxes at Mines and Geosciences Bureau and the local fees, charges, taxes to appropriate collecting offices.
- 7. The Ore Transport Permit (OTP) will be issued by the Mines and Geoscience Bureau Regional Office No. 4B.
- 8. Coordination and undertaking with other agencies shall be done by the Qualified Applicant after securing the NTP and OTP.

NOW, THEREFORE, be it RESOLVED AS IT IS HEREBY RESOLVED, to adopt he above implementing guidelines as the for the review and approval of the Delta Clearing and Shoreline Enhancement Plans as submitted by the various proponents of the River Restoration Projects for the Mitigation of Floods in the Province of Occidental Mindoro.
