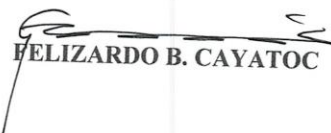

The Launching of the Community-Based Forest Management (CBFM) Strategic Plan 2023-2032 is co-organized by the Forest Management Bureau and Yakap Kalikasan Tungo sa Kaunlaran ng Pilipinas, with funding support from Forest Foundation Philippines (FFP). The Forest Management Bureau will invite various CBFM stakeholders including representatives from the CBFM-National Working Group (NWG), CBFM-People's Organizations (including the National Federation of CBFM-POs), government agencies, non-government organizations, civil society organizations, academe, and other entities, as necessary.

Expenses for food, accommodation and transportation of CBFM-People's Organizations are to be shouldered by Yakap Kalikasan Tungo sa Kaunlaran ng Pilipinas. Travelling expenses and/or allowable per diems of participants from DENR Central and Field Offices, and Bureaus shall be charged against funds of their respective offices, subject to the usual accounting and auditing rules and regulations. All expenses of FMB participants such as transportation, travel expenses, supplies and materials, and other costs pertinent to the event shall be charged against FMB 101 funds (CBFM-CARP), subject to the usual accounting and auditing rules.

A report shall be submitted to the undersigned within fifteen (15) days after the completion of the activity.

This Order takes effect on the dates specified therein.
