We are officially transmitting the BMB Memorandum on the call for proposals for funding under the IPAF-Special Account in the General Fund for FY 2025.

On the preparation of Special Budget Request (SBR), please be guided by BMB Technical Bulletin No. 2021-03, "Guidelines on the Use of the IPAF-RIA, IPAF-SAGF, IPAF-Trust Receipts and Providing the Criteria for the Allocation of Funds Deposited under the IPAF-SAGF in the National Treasury" which also prescribes the list of eligible activities that may be funded under the IPAF-SAGF. We would like to reiterate that proposed activities shall be used for the development of income-generating programs, projects, and activities consistent with the Protected Area Management Plan. Said programs shall serve as plow back mechanism for protected areas that will then be used to augment protected area management and operations.

To facilitate easier submission of your SBR proposals, please submit your SBRs to npd@bmb.gov.ph copy furnished frances.brillo@bmb.gov.ph\_on or before 31 January 2024. The complete SBRs with supporting documents shall be submitted upon our advice based on the deliberation of the BMB IPAF Review Committee which is scheduled in February 2024. Meantime, you may refer to https://bit.ly/IPAFSBR for the complete list and sample requirements in the preparation of SBRs.

For FY 2026-FY 2030, please also submit your priority protected areas with the corresponding budgetary requirements which shall serve as our roadmap for IPAF in the succeeding years. Attached is the template for the preparation of the IPAF Roadmap.
