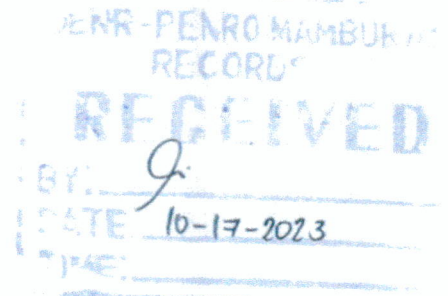

This is in connection to the official formal meeting re: Preparation and Titling of Lot held last October 11, 2023 at PENR Office, Mamburao, Occidental Mindoro, wherein selected PENRO's and CENRO's Staff were present.

On October 12, 2023 in the morning, a cellular phone call was received by one of the parties, LMI Ma. Menchie A. Quiñones from Engr. Eric Christian Custodio accusing the former of dishonoring the credibility and reputation of Engr. Custodio's brother Engr. Ricardo Lorenzo Custodio said that and I quote;

**"BAKIT NAMAN KELANGAN MO SIRAAN SI DICK
AT SABIHIN MO NA PENERAHAN NI DICK SI MR.
GUZMAN. NAKARECORD KA SA MGA SINABI MO."** unquote

After the cellular conversation, on the same day in the evening, Engr. Eric Custodio chat LMI Quiñones in her Messenger, and I quote:

**"GOOD PM ATE..YAN ANG HULING BINAYARAN KAY
DICK..293K FOR SURVEY AND APPROVAL, 250K PLUS
43K ADDL..SAN PO KAYA PAMEMERA JAN?"**

**"PATUNAYAN MO NGAUN ATE NA PENERAHAN NI DICK
C MR. GUZMAN AT NAKARECORD NA SINABI MO."**

The above-mentioned facts cause mental anguish, serious anxiety and moral shock to the personnel concerned. Aside from that sharing of information to other person who is not considered member of the organization is alarming which may put the life of the person in danger in particular and the integrity of the office, in general.

In lieu of this, may we request for investigation of the matter by creating a fact-finding team for the existence of violations under the law:

1. Violation of Republic Act 4200 otherwise known as “An Act to Prohibit and Penalize Wire Tapping and Other Related Violations of the Privacy of Communication and for other purposes;”
2. Cyber Libel under Republic Act No. 10175 or “Cybercrime Prevention Act of 2012;” and
3. Moral Damages under the Civil Code of the Philippines.

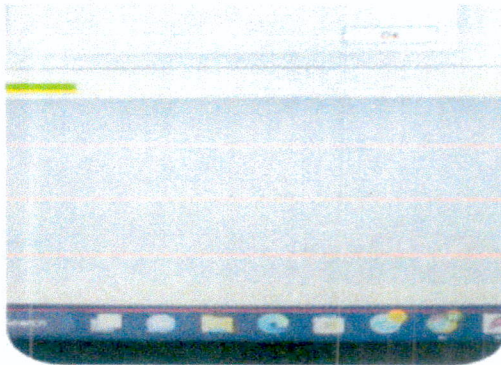

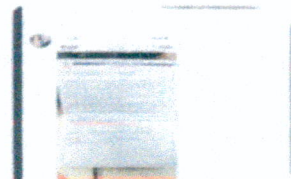
