In memorandum dated October 13, 2010 from the OIC CENRO Benjamin R. Jovinal thru OIC-PENRO for The Regional Executive Director of DENR-IV-B MIMAROPA with the subject **"Final Investigation Report on land case captioned as Heirs of Pacifico Ibabao Rep. by Jocelyn I. Francisco as Claimant Protestant versus FPA (unnumbered) of Heirs of Clarita I. Amar Rep. by Rodolfo I. Amar as Applicant-Respondent covering Lot 9998, Cad-346-D with an area of 0.6486 has. Located at Pili, Looc, Romblon."** The said Final investigation report consisting of sixty (60) pages was submitted for evaluation and issuance of Decision.

Further, I made a follow through a letter dated June 3, 2019 which led to the issuance of Memorandum dated June 20, 2019 by OIC, PENR Officer of Odiongan, Romblon, Mr. Gerardo B. Sabigan.
