Likewise, Resource Persons from other government agency/s, academe, and FMB's Assisting Professional for the conduct of Multi-Stakeholder Regional Action and Communication Plans for the Updated CBFM Strategic Plan (2023-2032) shall be invited to discuss topics related to CBFM and CBFM-CARP.

Expenses such as food and accommodation, use of conference hall, supplies/materials, and other necessary expenditures and fees of/for all participants shall be charged against FMB Fund 101 (CBFM-CARP). Travelling expenses and/or allowable per diems to be incurred by FMB personnel, officers of the National Federation of CBFM People's Organizations, Resource Person/s from other government agency/ies and FMB's Assisting Professional shall be charged against FMB Fund 101 (CBFM-CARP). On the other hand, travelling expenses and/or allowable per diems of DENR Central and Regional Offices' participants and representatives from the PARC Secretariat shall be charged against funds of their respective offices, subject to usual accounting and auditing rules and regulations.

The Director of Forest Management Bureau is authorized to reschedule the activity in case of conflict with other activities of the Department.

A report shall be submitted online (bit.ly/LDNportal) to the undersigned through the Human Resource Development Service - Training and Development Division fifteen (15) days after the completion of the activity.
