Acosta at Hon. Manuel Ang, ayon sa pagkakabanggit. Ito rin ay nilagdaan at nasaksihan ni Barangay Tanod Pacaul sa pag-inspeksyon sa lugar.

Noong July 2022 ipinasurvey nila ni Gino Cadungog ang area na ni waive ni Ramises Marañon sa kanila (kahit hindi lang si Ramesis, ang may karapatan sa lupang ito, kung hindi ay ang tatlong magkakapatid, Ramises, Ako (asawa ni Raymond) at Marifel. Sinadyang pinasok at ilegal na isinama nila ang parte ng area naming, alienable at disposable(released)na, sa pagsukat/pagsurvey na hindi namin namalayan, at pagkatapos ay kinuhaan nila ito ng certification. Hindi rin ako nag-waive sa kanila ng parte nang lupang ito. Kayat itong certification na ini-issue nang DENR-Mimaropa sa kanila ay "fraudulent".

Habang ang sobra sa lupa nina Rogelio at Nenita ay ipina-survey nina Simbajon at Cadungog sa DENR-Roxas na naging kanila na. Makikita po na nagkaroon si Cadungog ng parte sa lot no. 4921 gayong hindi siya kasali sa tatlong tagapagmana o anak nina Maranon.
