#### I. EVALUATION OF THE COURSE:

#### • Technical Content:

The 5-day activity of ENR Frontline Course conducted last October 23-27, 2023 via zoom platform enhanced our knowledge and appreciation on the implementation of Environmental Laws on the guidelines provided thereat. With the course primary objective to strengthen the quality of service of the Provincial Environment and Natural Resources Office (PENRO) and the Community Environment and Natural Resources Office (CENRO), it was indeed gave us insights and knowledge to deal with our day to day task.

#### Highlights of the activities

#### Day 1. October 23, 2023

The program, facilitated by the DENR MIMAROPA HRDS, welcomed the participants and discussed its house rules for the whole sessions. Subsequently, the facilitator gave a pre-test determine the knowledge of participants in the subject matter.

After the examination, Mr. Nazar Norman S. Cortuna, Chief, Accounting Section of Finance Division of the DENR MIMAROPA Regional Office initiated the training/lecture proper through presentation of Financial Literacy (Financial Planning, Saving and Budgeting). To capacitate the participants for financial stability, Mr. Cortuna discussed financial literacy, financial education and budgeting.

#### Day 2. October 24, 2023

Morning session- Ms. Amor D. Asi, Sr. Ecosystems Management Specialist from PENRO Oriental Mindoro started the session discussing the Forest Resources Management Services through presentation of FMB mandates and milestones. These includes presenting the EO 26 or the National Greening Program, its importance and relevance in the protection and conservation of the environment. Several legal issuance pertaining to conservation and protection of forest and natural resources were also discussed. Ms. Asi presented the importance of tenurial instruments such as SIFMA, IFMA, CBFMA, SLUP, FLAGT, FLAg and GSUP, which is beneficial to proponent and the environment. PD 705 otherwise known as Revised Forestry Code of the Philippines was added in the discussion.

**Afternoon session**, the Environmental Management Services presented other important environmental laws such as RA 6969, also known as "Toxic Substance and Hazardous and Nuclear Wastes Control Act of 1990", RA 9275 also known as "Clean Water Act of 2004" and RA 9003 otherwise known as "Ecological Solid Waste Act of 2000". Ms. Fe Rioflorido of EMB MIMAROPA presented these legal issuances.

# Day 3. October 25, 2023

**Morning session**. Attorney Lenel Rabeje discussed the Red Tape Act, Graft and Corruption Act and RA 6713 otherwise known as the "Code of Conduct and Ethical Standard for Public Officials and Employees" and RA 11032 or the Ease of Doing Business, which serves as safety guidelines for employees.

**Afternoon session.** Community Environment and Natural Resources Officer Rodel M. Boyles discussed the importance of biodiversity by highlighting RA 11038 otherwise known as the "Expanded National Integrated Protected Areas System Act of 2018" as amended, and RA 9147 otherwise known as the "Wildlife Resources Conservation and Protection Act". This will provide insights the legal provisions and on the management, conservation and protection of wildlife and natural resources.

### Day 4. October 26, 2023

**Morning session.** Mr. Marlon Mariñas of the National Mapping and Resources Information Authority (NAMRIA) discussed mapping matters provided by their Office.

Engineer Renzil Lladonet of Mines and Geo Sciences Bureau (MGB) discussed the Mining Resources and Management Services, its mandates and legal issuances relative to mining activities in the country.

**Afternoon session.** Ms. Edna Tarrosa, Chief, HRD Section of the Regional Office, presented the Quality Management System and the Administrative Order No. 161 S. of 2016.

# Day 5. October 27, 2023

**Morning session**. Mr. Jimmy C. Villareal, LMO III/Chief, RPS of PENR Office Palawan defined the Land Management and Land Composition of the country. He also discussed the different classification of lands according to ownership and the requirements on the application for Special Free Patent and other land related applications.

**Afternoon session.** Ms. Edna Tarrosa, Chief, HRD Section presented the Client Service Excellence, the 10 commandments of great client service, the essential client service skills and others. Further, she highlighted the DENR Mandates, DENR Mission, Vision, and DENR Core Values, which will, remind the participants the primary objective of this Office.

The culminating event was conducted with awarding and presenting of the ENR Frontline Course graduates.

#### • Impression/Comments:

Overall, the five-day lecture enhanced my knowledge on the legal bases of environmental protection and conservation. This will serve as guidelines especially as frontliner in the implementation and enforcement of environmental laws.
