
AND

WHEREAS, the Protestant's predecessor-in-interest sold (4) lots to the father of the Protestee's predecessor-in-interest, Romeo Ebediente, who later on waived the subject lot to her;

WHEREAS, the Protestant's father owns another lot known as Lot 10;



WHEREAS, both parties have come to a mutually beneficial arrangement as to the method of payment and mode of settlement of the instant case for their mutual benefit and the promotion of the common good;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements herein established, the parties hereto agree that the PROTESTEE will pay an amount of Fifty Thousand Pesos (P 50,000) for the transfer of the PROTESTANT'S house to another property identified as Lot 10 by her father/donor Rufo Dumandan, Jr., and all the improvements introduced on Lot 7, Block 17, Ccs-045316-001178-D and the PROTESTANT is likewise willing to abandon her protest to the issuance of the title in the name of the PROTESTEE.



Both parties have executed this Agreement by their own voluntary act and deed and in their mutually agreed terms. Both parties warrant further, that they did so with the full understanding of its nature and its consequence to the instant case.
