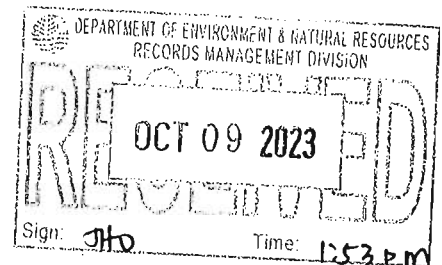

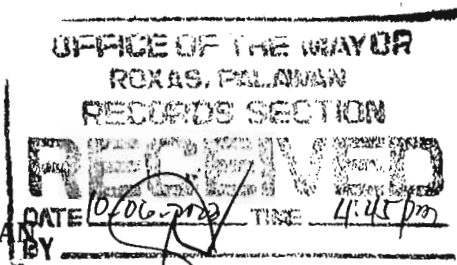

**WHEREAS**, it is the policy of the State to sustainably manage, protect and conserve the country's forest resources while reducing poverty, promoting food security, environmental stability and biodiversity conservation, enhancing climate change mitigation and adoption;

**WHEREAS**, Executive Order No. 193, signed by then President Benigno Aquino III on November 12, 2015, provided the National Greening Program to rehabilitate all the remaining unproductive, denuded and degraded forest lands estimated at 7.1 million hectares from 2016-2028;

**WHEREAS**, consistent with the Master Plan of the DENR, particularly in the Forestry Sector (2016-2028) to harmonize all forest development activities that will enhance

development of forest plantations with the participation of private sector, local government unit and people's organization, this LGU is urgently proposing the rehabilitation of an estimated 5,000 hectares of denuded and unproductive forest lands in the different barangays of this municipality;

**NOW THEREFORE**, on motion by Hon. Rey D. Pura, unanimously seconded, be it;


