To whom it may concern,

The International Oil Pollution Compensation Funds (IOPC Funds) and ITOPF, working in partnership with the Philippine Coast Guard (PCG) duly invite yourself and representatives of your department to a two-day **'Claims and Compensation Workshop in relation to the MT PRINCESS EMPRESS oil spill incident'**.

The workshop will take place on **November 14<sup>th</sup> and 15<sup>th</sup> 2023**, and be held at the **Function Hall of the National Museum of the Philippines, Manila**.

The purpose of the workshop is to provide support and advice to all government agencies wishing to submit a claim for compensation for work conducted in relation to the PRINCESS EMPRESS incident of 28<sup>th</sup> February 2023.

It is intended that provision of this platform to share brief presentations and a face-to-face discussion of claims, prior to their official submission, will expedite the assist in the compilation of, and the efficacy, of Philippine Government claim submissions. With this in mind, all relevant departments should attend. The attending representatives should have the detailed knowledge and authority to discuss their intended submissions.

The workshop will be separated into 4 separate sections over two days to consider claims for clean-up, tourism loss, fisheries loss and environmental damage. The timetable is shown overleaf.

Each session will start with a brief overview of the principles of admissibility and reasonableness for the particular type of compensation available. Following this, any department that is anticipating making a claim should provide a brief presentation (up to 15 minutes) of their intended submission and any questions of clarification that are required. Following the presentations, an open discussion of any issues or concerns will be held. Depending on the number of claimants, this discussion may be held as a single item involving all attendees, or smaller break-out discussions may be held between facilitators and separate departments.

**It is requested presentations, or a brief overview of the intended claim are submitted to the IOPC and ITOPF no less than 14 days prior to the workshop. This is intended to maximise the benefit of the shared time in Manila.**

Please confirm your attendance by October 10<sup>th</sup> and address any questions you may have to Atty. Gerson B Gamas.

We look forward to meeting with you in November.
