In reference to your request, we are pleased to provide you with complimentary copies of the following Land Cover Map (LCM) in a shapefile format covering a portion of Coron, Palawan:

1. 2020 Land Cover data series generated from 2018-2019 Sentinel-2 satellite imagery (10m resolution) with ground validation;
2. 2015 Land Cover data series generated from 2013-2015 Landsat 8 OLI satellite imagery (30m resolution) with ground validation; and
3. 2010 Land Cover data series generated from 2007-2011 ALOS AVNIR-2, 2006-2009 SPOT satellite imagery (10m resolution) and 2010 Landsat 7 ETM satellite imagery (30m resolution) with ground validation;

The datasets are projected in Universal Transverse Mercator (UTM) Zone 50 with Philippine Reference System 1992 (PRS92) as a horizontal datum.


Further, we are also providing satellite imagery, showing the three (3) reclamation areas in Coron, Palawan, and the Mangrove Forest Statistics, for your reference. Please note that NAMRIA does not issue any certification regarding the Land Cover Maps.

Further, NAMRIA is now implementing its Open Data Policy as part of the Philippines' commitment to Open Government Partnership and the agency's engagement with Open Data Philippines. With this development, various NAMRIA's geospatial data holdings in GIS format are now published and accessible via online using the Geoportal Philippines (www.geoportal.gov.ph).
