In an effort to keep up with the growing risk of cyberattacks in various organizations, both public and private, we are requiring Active Directory and Information Systems accounts holders to harden their respective passwords by using a combination of the following:

- At least eight (8) characters;
- Uppercase (capital) letters (e.i A, E, R);
- Lowercase (small) letters (e.i. a, e, r);
- Numbers. (e.i. 2, 6, 7); and
- Symbols and special characters (e.i. ! @ & *)

For example: WeL0v3@D3Nr

It is also the responsibility of every user to ensure that his/her password remains his/her personal property and not to be shared with any other individuals. The Department reserves the right to hold the user liable for damages caused by his/her failure to protect the confidentiality of his/her password in accordance with these measures. You are given until **October 20, 2023, Friday 5:00 PM**, to comply.
