This has reference to the agreement reached during the Technical Working Group (TWG) Meeting on July 28, 2023 at DILG-NAPOLCOM Center, Quezon City, relative to the Validation of Masterlist of Land Area for the Computation of National Tax Allotment (NTA) shares of LGUs.

Please be informed that the meeting was facilitated by the DILG, headed by USEC Marlo L. Iringan, Undersecretary for Local Government. It was attended by Engr. Bienvenido F. Cruz, Chief, Geodetic Surveys Division and some LMB personnel and the TWG of the Validation of Masterlist as per Oversight Committee Devolution (OCD) Resolution 1, series of 2005, which is composed of NAMRIA, DILG and Leagues of Cities and Municipalities.

It was agreed that the DENR Regional Offices shall conduct a meeting with their respective LGUs either in person, or through online platform in order to properly disseminate information regarding the data of the 2019 Masterlist of Land Area for Cities and Municipalities. The conduct of the Meeting should be completed by the end of December 2023.

It was also mentioned during the said TWG meeting that the conduct of information dissemination to the LGUs will help the TWG in the crafting of ways forward for the Congressional Committee on Devolution (CCD) and OCD meeting that will convene soon.

In view thereof, a meeting with your Chief, Surveys and Mapping Division (SMD) regarding the Strategies for the Information Dissemination Campaign on the Masterlist of Land Area for Cities and Municipalities was conducted last September 19, 2023 at Harolds Evotel, Timog Avenue, Quezon City. As such, you are advised to undertake immediately the said activity considering that we only have three (3) remaining months to comply with the said agreement.

Attached is the copy of the Minutes of the said agreement for your ready reference.
