



## BY THE PRESIDENT OF THE PHILIPPINES

**PROCLAMATION NO.718** 

AMENDING EXECUTIVE ORDER NO. 67, DATED OCTOBER 15, 1912, WHICH ESTABLISHED THE IWAHIG PENAL COLONY IN PALAWAN, BY SEGREGATING PORTIONS OF THE LAND EMBRACED THEREIN AND DECLARING THE SAME AS CIVIL RESERVATION FOR RESETTLEMENT AND AGRICULTURAL SITES PURPOSES

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, I, GLORIA MACAPAGAL-ARROYO, President of the Republic of the Philippines, do hereby amend Executive Order No. 67, dated October 15, 1912, which established the Iwahig Prison and Penal Farm in Palawan, by segregating portions of the land embraced therein and declaring the same as civil reservation for resettlement and agricultural sites purposes, subject to actual survey, and to private rights, if any there be, which parcel of land is more particularly described as follows:

#### LOT 1

A PARCEL OF LAND, (being a portion of Iwahig Prison and Penal Farm by virtue of Executive Order no. 67, Series of 1912), situated at Sitios Malamig and Bocana, Barangay Iwahig, City of Puerto Princesa, Island of Palawan. Bounded on the North by the property of the Department of Agriculture; on the East by Puerto Princesa Bay; on the South by Balsahan River; and on the West by the National Highway (60.00 m. wide). Beginning at a point marked "1" being North 65 deg. 56' West, 9,116.75 m. from B. L. L. M. No. 1, Cad-800-D, Puerto Princesa Cadastre, thence:
