This is to respectfully transmit the attached memorandum from the National Economic and Development Authority-Central Office (NEDA CO) relative to the updating of the PIP 2023-2028 and formulation of the TRIP for FYs 2025-2027 as input to the FY 2025 Budget Preparation, for reference and guidance.

Background

1. On 13 October 2023, the NEDA CO issued a memorandum on the subject containing the guidelines and procedures for the updating of the PIP 2023-2028 and formulation of the TRIP for FYs 2025-2027.
2. The memorandum also included the calendar of activities for the preparation of the two documents. In particular, the submission and endorsement of priority PAPs for inclusion in the PIP/TRIP through the PIPOL system is from 13 October 2023 to 15 November 2023.
