In reference to the National Disaster Risk Reduction and Management Plan (NDRRMP) 2020-2030, all Regional Disaster Risk Reduction and Management Councils (RDRRMC) are required to formulate the respective Regional Disaster Risk Reduction and Management Plans (RDRRMP), which encompasses the actionable strategies to be implemented at the Regional Level, to achieve the objectives of the NDRRMP. The RDRRMP aims to create a coherent, coordinated, and customized Regional approach to DRRM, and aligns the Regional efforts with the National Strategy, while addressing the specific Regional vulnerabilities, hazards, and needs. The RDRRMP shall be developed, in coordination from the various Regional Line Agencies, Local Government Units, as well as other stakeholders, to ensure a collaborative effort to foster an integrated approach.


The formulation of the RDRRMP involves identifying the resources allocation planning, and identifying the strategies for building the Regional and Local capacities to effectively implement DRRM measures. Further, the RDRRMP shall be integrated in development planning to ensure that DRRM is considered in all aspects of development.

In this regard, all RDRRMC MIMAROPA Member Agencies and P/CDRRMOs are respectfully requested to submit their respective agency-specific proposed Programs, Projects and Activities (PPAs) with corresponding targets, timelines and resources required, which is aligned to the Outcomes, Outputs, and Activities per

Thematic Pillar under NDRRMP 2020-2030 (please see attached matrix). The proposed PPAs are requested to be submitted on or before 17 November 2023 for the consolidation of the RDRRMC Secretariat, through the Office of Civil Defense MIMAROPA. Please see attached copy of the NDRRMP 2020-2030 for your reference and guidance.
