


SUBJECT : **LETTER DATED MARCH 17, 2023 FROM COL. JERICK A. DOLLENTE PAF (GSC)**

They are requesting assistance and support to relocate the 2,500 hectares Military Reservation located in Mt. Salakot, Barangay Bagong Bayan, Puerto Princesa City. The said military reservation is covered by Proclamation No. 1719 dated February 27, 1978 and signed by then President Ferdinand E. Marcos.

In order to facilitate the identification of boundaries, we need to obtain a copy of the map of TLA No. 245 issued to Palawan Apitong because the boundaries are mainly identical to the boundaries of TLA No. 245.
