I would like to follow up regarding respondent Rodney Verian side on the matter as he is the one that I am complaining of, see all attached files in this recent complain dated Sep 12 when he intentionally blocked our driveway, parking in front of our gate, see evidence of proof. Pictures don't lie, my complain dated Sep 13, until now the respondent has not explained his side. VIOLATION of Government campaign Anti Redtape.

See attached files that the Penro officer sending email to respondent without asking to explain his unlawful misconduct.

See attached file that Penro officer send email to Barangay informing the same, while my complains since 2021 is a series of all misconduct of Rodney Verian an employee of DENR Palawan who's continually until now doing a series of grave misconduct towards us.

Kindly review all my complains since 2021, all with proof of evidences, Pictures and complains.

That this matter is beyond barangay, redundances, that's why I told Mr Cayatoc that he is my last resort.

Why until now the respondent still doing mean and provocative, untoward, grave misconduct.

My September 12 report stating he parked and blocked our driveway IS MERE VIOLATION OF DPWH STATUTORY PROHIBITION ON OUR NATIONAL LAW of traffic rules for ILLEGAL PARKING. The respondent of course is a license driver aware that parking in-front of another's gate/driveway is unlawful, he is a public servant that violating respectively and yet is just ok not to be held liable for it?

Today as of this writing, see pictures, he hired as per the person involved, they are senior citizens, by their will of course, working for Rodney to pick up aggregates in our developed parking lot last 2021, picking all they might to fill up the road that has flooded and eroded. Senior citizens that working in the middle of the sun.

And to add it up, please be informed that the place where he instruct senior citizen to get aggregates is our paid aggregates to develop our parking lot last 2021, since he complaining that we don't have parking for our guests. We spend renting and paid thousands for aggregates to develop our parking, when lean season arrive, and not updated paying parking lot, he grab the opportunity to illegally placed his in operative car and parked it permanently, he stated and attached file that he pays for rent in acknowledgment letter that written in grade 4 pupils notebook.

Where in fact the one that he rented as I heard from lot caretaker was at his backyard, he developed and fenced with boho, but he didn't use it because it is flooded. I can show picture of it, but instead he parked and permanently placed his car in our progressed previously developed and rented park space, where he never spend even single peso. Now he hired senior citizens to get some aggregates and used it, he place his car and now even getting aggregates? Where is the so called DELICADESA?

Last month parking in front of our gate, this month using our aggregates for his instructions. Since 2019 files of his and his family misconducts, all of them affiliated to DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES.

He alledged that our villa has no permit? I wonder why we cannot secure ECR to have our permit complete.

I have thank GOD when he transferred to Coron, our place has its peace, I feel vindicated and justice fair enough indeed.

Good and pleasant day to all.

This is in reply to the complaint filed by Mr. Elbert Reynoso dated January 24, 2022 emailed to various offices, that accordingly the undersigned violated provisions of RA 7183 "An Act Regulating the Sale, Manufacture and Use of Firecrackers and other Pyrotechnic Devices" and Executive Order 28 "Providing for the Regulation and Control of the Use of Firecrackers and other Pyrotechnic Devices" on 2022 New Year celebration by using Belt of Judas.

Please be informed that as per Philippine National Police list of allowed and prohibited firecrackers published in the article dated December 17, 2021 by Priam Nepomuceno of Philippine News Agency enumerated Juda's Belt under firecrackers that are regulated for sale and use along with Baby Rocket, Paper Caps, Sky Rocket (Kwitis), etc.. Likewise, the said firecrackers was purchased in a legal source and from legal stores designated by The City Police of Puerto Princesa. Hence, and again the complaint is baseless and meant to malign my name and reputation.

With regards to his previous emailed complaint on February 2021, the matter was already answered by the undersigned dated February 18, 2021 thru emails addressed also to different agencies which he (Mr. Reynoso) sent his complaint.

To show that the matter has already long been answered, complied and acted. Attached are geotag pictures of various dates and a Certification signed by Barangay Captain Salvador and Barngay Kagawad Deguzman dated July 26, 2021 for perusal and record.
