These activities include, but are not limited to the following:

 - b. Processing of mining applications and related permits
 - c. Mineral Production Sharing Agreements
 - d. Financial and Technical Assistance Agreements
 - e. Mineral Processing Permits
 - f. Area clearances for sand and gravel
 - g. Other government projects including NGP and SWCs, among others
- B. Ongoing Applications Including Renewal:
 - a. Exploration Permits
 - b. New Mining Applications

Please ensure that your assessments are submitted by October 23, 2023, to allow time for consolidation. Additionally, all Regional Executive Directors are instructed to attend the meeting on 25 October 2023 in Quezon City for the presentation of their findings.

The Forest Management Bureau (FMB) is instructed to provide shapefiles of the said 131 critical watersheds to all DENR Regional Offices for their ready reference.
