Update Report:

Re: Request For Issuance Of Title for Imperfect Title of Land of Lodovico Ormido by virtue of approved FP- 4535 and Plan II-7480 with Barangay Certification from Punong Barangay Enrico Sadang of Barangay Guadalupe. Update Report as of October 24, 2023:

That to date, I was handed a letter dated September 19, 2023 received by me on October 17, 2023 from CENRO Verian instead of the Certification committed to the undersigned by the DENR Records Department personnel at DENR Coron, Palawan, instructing me that my Certification request needed the signature of CENRO Verian, as required by the Municipal Assessor's Office Coron, Palawan, Samuel Alarcon for my application for Tax Declaration of our survey approved land but to my dismay was a letter a copy attached hereto was his answer.

Please take notice that the Assessor's Office Coron, Palawan needed the Certification from the DENR-Coron to finally issue me my Tax Declaration of the same land for taxation purposes. May I comment that the Certification as committed to me somehow is very relevant as to the service I am requesting from the DENR Office. I believe that the status of our land having now declared by DENR-Coron thru CENRO Verian's letter as "Unclassified Forest" and yet up to now is an Imperfect Title at that, such prestation since 1912 our land undertook the Approved Land Survey and Status, thus the Local Government Code of 1991 was in effect after 1991, and before that our land remains its status until today, CENRO Verian upheld the Local Government Code of 1991 but the same do not prejudice our land being an Imperfect Title. In my humble research, the Book, Philippine Laws on Property by the distinguished Miriam Defensor Santiago, tells that all prestations done by the government before the Local Government Code of 1991 is deemed in effect, and therefore my request for final registration of our land be fully served. Please take notice that all need support documents including the original approved survey, Original Plan Tracing Cloth Diazo Polyester Film ,original white and blue print copies of the plan all in the archive of DENR-MIMAROPA. Again, I am until today praying to your good office to grant us our needed assistance for the final registration of our land. Please be informed that I was given due certification for actual occupancy by the Punong Barangay of Barangay Guadalupe, Coron, Palawan which was before a prior requisite of the DENR-Coron for their issuance of final Certification they so required the undersigned had until now is not served by the DENR.
