This refers to the electronic letter received by our Office dated 26 October 2023, the Committee on Indigenous Cultural Communities and Indigenous Peoples of the House of Representatives will hold a **face-to-face Technical Working Group (TWG) Meeting on 08 November 2023, Wednesday, 2:00 PM at Room 6, Ramon V. Mitra Building, House of Representatives** on the following legislative measures:

- **HOUSE BILL 1064** - "AN ACT TO ENSURE EQUAL EMPLOYMENT OPPORTUNITIES TO MEMBERS OF INDIGENOUS CULTURAL COMMUNITIES AND PREFERENCE IN CERTAIN CASES AND FOR OTHER PURPOSES" Introduced by Rep. Luisa Lloren Cuaresma;

- **HOUSE BILL 4294** - “AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE SYSTEM OF REGISTRATION CONCERNING THE CIVIL STATUS OF INDIGENOUS PEOPLES AND FOR OTHER PURPOSES” Introduced by Reps. Arlene D. Brosas, France L. Castro, and Raoul Dannel A. Manuel;
- **House Bill No. 6641** - “AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE CIVIL REGISTRATION FOR INDIGENOUS PEOPLES” Introduced by Rep. Rufus B. Rodriguez; and
- **House Bill No. 3340** - “AN ACT ESTABLISHING A SYSTEM PROTECTING THE COMMUNITY INTELLECTUAL RIGHTS OF INDIGENOUS CULTURAL COMMUNITIES/INDIGENOUS PEOPLES” Introduced by Rep. Maximo. Y. Dalog, Jr.
