Mitra Building, House of Representatives** on the following legislative measures:

• HOUSE BILL 1064 – "AN ACT TO ENSURE EQUAL EMPLOYMENT OPPORTUNITIES TO MEMBERS OF INDIGENOUS CULTURAL COMMUNITIES AND PREFERENCE IN CERTAIN CASES AND FOR OTHER PURPOSES" Introduced by Rep. Luisa Lloren Cuaresma;

- HOUSE BILL 4294 "AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE SYSTEM OF REGISTRATION CONCERNING THE CIVIL STATUS OF INDIGENOUS PEOPLES AND FOR OTHER PURPOSES" Introduced by Reps. Arlene D. Brosas, France L. Castro, and Raoul Danniel A. Manuel;
- House Bill No. 6641 "AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE CIVIL REGISTRATION FOR INDIGENOUS PEOPLES" Introduced by Rep. Rufus B. Rodriguez; and
- House Bill No. 3340 "AN ACT ESTABLISHING A SYSTEM PROTECTING THE COMMUNITY INTELLECTUAL RIGHTS OF INDIGENOUS CULTURAL COMMUNITIES/INDIGENOUS PEOPLES" Introduced by Rep. Maximo. Y. Dalog, Jr.
