In reference to the electronic letter received by our Office on 30 September 2023, the Committee on Ecology of the House of Representatives will hold its 6<sup>th</sup> Small Technical Working Group (STWG) Meeting on **05 October 2023, Thursday, 10:00 AM via Zoom,** on the following legislative measures:

- HOUSE BILL 1423 AN ACT AMENDING SECTION 9 OF PRESIDENTIAL DECREE 1586 BY INCREASING THE PENALTIES THEREOF AND FOR OTHER PURPOSES (by Rep. Ramon N. Guico Jr.); and
- **HOUSE BILL 7959** AN ACT TO RATIONALIZE THE PHILIPPINE ENVIRONMENTAL IMPACT ASSESSMENT SYSTEM, AND FOR OTHER PURPOSES (by Rep. Marlyn B. Alonte).

In addition, a 3<sup>rd</sup> bill on the Environmental Assessment System (EAS) serves as the working draft for the group discussion, to wit:

• **HOUSE BILL 8594** — AN ACT TO ESTABLISH THE PHILIPPINE ENVIRONMENTAL SYSTEM AND FOR OTHER PURPOSES (by Rep. Marlyn B. Alonte).
