Subject: HACT Assurance Activities for the Department of Environment and Natural Resources (DENR)–Integrated Approach in Management of Biodiversity Corridor in the Philippines (BD Corridor Project) and Implementing the National Framework on Access and Benefit Sharing of Genetic Resources and Associated Traditional Knowledge in the Philippines (ABS Project)–Programme Output Verification

As part of the Harmonized Approach to Cash Transfer (HACT) of the United Nations Development Programme (UNDP), we will be conducting a programme output verification assurance activity for the BD Corridor and ABS Projects.
