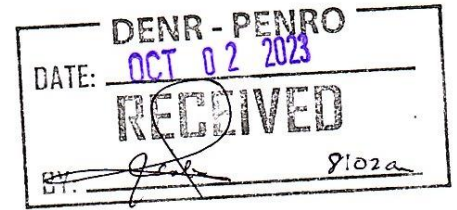

WHEREAS, the Local Government of Magdiwang, Romblon owns a parcel of land with Lot No. 12-M-2 located at Barangay Poblacion, this municipality with a total area of more or less 11,313 square meters;

WHEREAS, it is of great advantage that an important national office such that of the DENR has a sub-office in the town proper which is only few meters away from other government offices and agencies, including that of the Municipal Building;

WHEREAS, Sections 22(c) and 444(b)(1)(vi) of the Local Government Code require a prior authorization by the sangguniang bayan before the Municipal Mayor may represent the municipality in all its business transactions and sign on its behalf all contracts and obligations;




