Greetings of Peace!

I am writing in behalf of my client, FM SALCEDO & SONS, INC..

Re the above-subject, may we ask for your personal intervention to finally resolve the “technical issues” of the two lots.

During our previous meetings, the DAR Provincial Office of Oriental Mindoro has stated that these two lots lack the “narrative technical description”. Please refer to the memorandum of the PARO of Oriental Mindoro dated June 7, 2023.

This matter has prevented the Land Bank of the Philippines (LBP) from releasing the payment of just compensation in favor of my client, FM SALCEDO & SONS, INC.. Please refer to the letter of LBP to PARO of Oriental Mindoro dated January 25, 2023.

These lots have been the subject of previous communication between DARPO and DARRO/DARCO.

My client agreed to withdraw its protest on the CARP coverage of its properties in the expectation of a quick payment of just compensation. The protest was filed in February 2014 and dragged on for many years before it was ruled that the protest was barred by laches.




The client really wanted to pursue its protest but the expectation of a quick payment of the meager just compensation persuaded it to withdraw. It is becoming evident that its expectation is unfounded.

However, we believe that with your personal intervention, this matter of lack of “narrative technical description” could be resolved with utmost dispatch.


We respectfully submit an update and inventories conducted by the F.M. Salcedo, Inc. Task Force for the following properties. to wit:

Please be informed also that the narrative technical descriptions of untransferred lots of T-9975 under OLT was forwarded by DARPO to BLTI on April 26, 2022 as directed.

However, we have not received yet the narrative technical descriptions for the seventy-nine (79) hectare-portion of T-9976 from DENR. Hence, we requested for your assistance in securing the said NTDs in our memorandum dated March 22, 2023.

With respect to the property embraced by Title No. RT-103 T-93 with an area of 18.7589 hectares located at Leido, Victoria, Oriental Mindoro based on the CSW submitted by MARPO Ophelia L. Radovan dated March 24, 2023, the coverage of said property under OLT did not pursue due to its swampy condition being proximate to Naujan Lake. Likewise, the subject landholding was not recommended for CARP coverage and not issued with NOC because it is largely unproductive due to same condition of the area.
