OPERATIONS OF ALTAI PHILIPPINES MINING CORPORATION (SIBUYAN, ROMBLON – MINING ACTIVITY)

BACKGROUND INFORMATION

This Office acquired jurisdiction over the Altai Philippines Mining Corporation (APMC) through regular monitoring of its compliance with environmental laws (i.e., RA 8749 (Clean Air Act of 1999), RA 9003 (Ecological Solid Waste Management Act of 2000), RA 9275 (Philippine Clean Water Act of 2004), RA 6969 (Toxic Substances and Hazardous and Nuclear Waste Control Act of 1990), and PD 1586 (Philippine Environmental Impact Statement).

WAYS AHEAD

This Office shall continue to conduct regular monitoring activities on the project site and ensure that the structures which have been issued permits comply with pertinent environmental laws and regulations. Furthermore, this Office shall continue to collaborate with the Office of the Solicitor General pertaining to legal matters in the case of Batan et. al. vs. DENR.

OIL SPILL INCIDENT IN NAUJAN, ORIENTAL MINDORO

ACTIONS TAKEN

WATER QUALITY MONITORING

Since 01 March 2023, EMB – MIMAROPA Region along with our technical teams from the Regional Environmental Laboratory, Provincial Environmental Management Unit (PEMU) – Oriental Mindoro and Occidental Mindoro have been working non-stop in collecting and analyzing the water samples for oil and grease from areas affected by the oil spill, coordinating and providing technical assistance to local government units and other concerned government agencies and assisting in clean- up operations.

During the first month of the oil spill incident, March 2023, samples were taken for the analysis of volatile organic compounds specifically the Benzene, Toulene, Ethylbenzene and Xylene (better known as BTEX) and polyaromatic hydrocarbons (PAHs). BTEX are highly water-soluble components that quickly volatilize and are rapidly lost to the atmosphere within hours to days during sea-surface oil spills. Similarly, large scale oil spills such as the Naujan Oil Spill can alao release PAHs into the receiving environment. Both BTEX and PAHs are known to be carcinogenic and mutagenic. Hence the analysis of BTEX and PAH during the first month of monitoring. The results yielded a not detected levels of both BTEX and PAH in all the samples collected from the shorelines of Naujan, Pola and Pinamalayan. These are the three hardest hit areas by the oil spill incident.

As of the latest available oil and grease result per affected shoreline, out of 96 established monitoring stations, 41 stations are already within the normal water quality guidelines while the remaining 55 stations still exceed the water quality guidelines.

To check again for the presence of toxic volatile compounds in the affected shorelines, last 23-24 August 2023, this Office conducted another water sampling for the determination of volatile organic compounds, the BTEX group (benzene, toluene, ethylbenzene, and xylenes). Samples were taken at the shorelines of Bulalacao, Mansalay, Roxas, Bongabong, Bansud, Pinamalayan, Pola, Naujan, Calapan City, Baco, San Teodoro and Puerto Galera. Samples were analyzed on 29 August 2023 and yielded a not detected result. Results are all below the instrument and method detection limit. To date, this Office is still waiting for the release of the results for the PAHs.

AIR QUALITY MONITORING

Air quality was also monitored through the stations of the Baco-Calapan City-Naujan (BCN) Airshed. The stations measure PM 10 and the filter paper samples were also sent for source apportionment analysis.

To ensure that the air is free from these emission of volatile organic compounds brought by the oil spill, this Office also measured VOCs in air (Benzene, Ethylbenzene, m,p-Xylene, o-Xylene and Toulene). The priority areas are in the barangays of Pola, namely Brgy. Misong, Brgy. Buhay na Tubig and Brgy. Calima. All stations yielded undetected levels of VOCs. No traces of the above-mentioned analytes were detected during the time of sampling.

WASTE COLLECTION AS OF 05 JULY 2023

This Office also monitored the safe collection of all the wastes generated during the cleanup activities. A total of 412,084.50L or 370,876.05kg of oil-contaminated materials were generated from Oriental Mindoro (Calapan City, Naujan, Pola, Gloria and Bongabong) and Palawan (Taytay). These were collected by the Harbor Star.

WAYS AHEAD

This Office commits to continuously monitor and strategize sampling frequency of water quality sampling in areas affected by oil spill. Further, for air quality monitoring, this Office commits to continue the source apportionment analysis for PM10 filter paper samples collected from Baco Station, Calapan Station, and Naujan Station of the BCN Airshed.

This Office shall monitor the implementation of the Clean-up Plan submitted by Harbor Star specifically on the hauling, storage, and disposal of hazardous waste. This Office commits to monitor confirmatory parameters in all affected shorelines to determine whether these pollutants are within toxic levels or not.
