RESOLUTION NO. 03, SERIES OF 2023

RESOLUTION FAVOURABLY ENDORSING THE PROPOSED CONSTRUCTION OF THE BUCAYAO GRANDE BRIDGE OF MAHABANG PARANG, NAUJAN, ORIENTAL MINDORO AND OF THE CONSTRUCTION OF THE BAILEY BRIDGE AT CAMBUNANG, BULALACAO, ORIENTAL MINDORO TO THE MIMAROPA REGIONAL DEVELOPMENT COUNCIL (RDC) FOR INCLUSION IN THE REGIONAL DEVELOPMENT INVESTMENT PROGRAM AND ENDORSEMENT TO APPROPRIATE NATIONAL GOVERNMENT AGENCIES, DEPARTMENT OF AGRARIAN REFORM (DAR), DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) AND OTHER AGENCIES FOR SUPPORT AND FUNDING

WHEREAS, the Provincial Government of Oriental Mindoro (PGOM) aims its developmental plans, programs, and projects towards being the "food-base exporting high value agri-products, the preferred agri-ecotourism destination in MIMAROPA, and with an environment conducive for investment" thus, the PGOM is geared towards an inclusive development of the agriculture sector in the province;

WHEREAS, the National Government is implementing the "Pang-Agraryong Tulay para sa Bagong Bayanihan ng Magsasaka" (PBBM Bridges)/ "Tulay ng Pangulo Para sa Kaunlarang Pang-Agraryo" (TPKP) that aims the provision of better infrastructure services in agrarian reform communities through the Department of Agrarian Reform and the Department of Public Works and Highways;

WHEREAS, members of the Mahabang Parang Agrarian Reform Beneficiaries Association (MAPARBA) requested the Construction of the Bucayao Bridge of Mahabang Parang, Naujan connecting Barangay Mahabang Parang and Barangay Malvar in Naujan to improve the transportation of agricultural goods and products to commercial areas and to improve the access to basic services, as specified in the Sangguniang Bayan Resolution 029-2023 of the Municipality of Naujan, Oriental Mindoro;

WHEREAS, Barangay Cambunang is an agrarian-reform community in Bulalacao whose primary source of income is the farming of onions, rice, garlic, corn, and varieties of fruits and vegetables, and the proposed Construction of the Bailey Bridge at Cambunang, Bulalacao aims to improve the farm-to-market access of the farmers in the community and permanently link the community to main road networks, as stated in the Sangguniang Bayan Resolution No. 23-03-066 of the Municipality of Bulalacao;

WHEREAS, the PGOM sees the need and opportunity in the improvement of infrastructure services to these agrarian reform communities through the TPKP Program of the national government, and its projected contribution to the economic and social development of the province;

NOW, THEREFORE, on motion unanimously approved;

The proposed Construction of the Bucayao Grande Bridge of Mahabang Parang, Naujan, Oriental Mindoro and Construction of the Bailey Bridge at Cambunang, Bulalacao, Oriental Mindoro in the amount of P80,694,810.00 and P53,796,540.00, respectively, is hereby endorsed to the MIMAROPA Regional Development Council (RDC) for inclusion in the Regional Development Investment Program and endorsement to appropriate national government agencies, Department of Agrarian Reform (DAR), Department of Public Works And Highways (DPWH), Department of

Environment And Natural Resources (DENR) and other agencies for support and funding.

FURTHER, RESOLVED AS IT IS HEREBY RESOLVED, to furnish a copy of this resolution to the MIMAROPA Regional Development Council (RDC) and other agencies for information and reference.
