## Dear Sirs and Mesdames,

Pursuant to Republic Act 7586 or the National Integrated Protected Areas System (NIPAS) Act, as amended, by RA 11038 or the Expanded NIPAS Act of 2018, the Biodiversity Management Bureau is currently developing the policy on the Rules of Procedures on Administrative Adjudication in Protected Areas. The proposed policy aims to provide a uniform procedure in the administrative adjudication of cases filed for violation of Sections 20, 21, 24 of the NIPAS Act, as amended, other related guidelines, rules, and regulations on protected area development and management.

In line with the Secretary's thrusts and direction to promote convergence among key stakeholders, ensure policy coherence, and ensure the readiness of the proposed policy prior to its submission to the Office of the Secretary, a **National Consultation Workshop will be held on 25-29 September 2023 (inclusive of travel time) in CALABARZON Region**. The Consultation Workshop will be a continuation of the National Consultation Workshop held on 5-9 June 2023 in Tagaytay City. The Consultation Workshop aims to solicit inputs and recommendations on the draft Rules of Procedures on Administrative Adjudication in Protected Areas, and identify issues, gaps and concerns from the implementation of the NIPAS Act, as amended, that may be addressed by the proposed policy.
