## Filing of Memorandum of Appeal Challenging the CDO of NCIP-MIMAROPA

We confirm that on September 15, 2023, or within the allowable 15-day period,<sup>1</sup> Celestial Nickel Mining Exploration Corporation and Ipilan Nickel Corporation filed their **appeal** to the National Commission on Indigenous Peoples (NCIP) Central Executive Board from the Cease and Desist Order (CDO) issued by the MIMAROPA Regional Office of the NCIP.

Under Chapter IX, Section 68 of R.A. No. 8371,<sup>2</sup> Rule VIII, Sections 34<sup>3</sup> and 35<sup>4</sup> of the 2018 NCIP Rules of Procedure, Rule IX, Section 4<sup>5</sup> of NCIP Administrative Order No. 1, Series of 1998, Book VII, Chapter 4, Section 15<sup>6</sup> and Book VII, Chapter 4, Section 21<sup>7</sup> of the Administrative Code of 1987, the timely filing of an appeal stays the execution of the CDO and prevents it from attaining finality.

<sup>&</sup>lt;sup>2</sup> Execution of Decisions, Awards, Orders. - Upon expiration of the period herein provided and no appeal is perfected by any of the contending parties, the Hearing Officer of the NCIP, on its own initiative or upon motion by the prevailing party, shall issue a writ of execution requiring the sheriff or the proper officer to execute final decisions, orders or awards of the Regional Hearing Officer of the NCIP.

If the 15th day falls on a Saturday, a Sunday or a Holiday, the last day shall be the next working day.
