This has reference to the undated letter from Rogel and Connie Morales, requesting for the extension of the Wood Recovery Permit (WRP) apparently issued to them for the retrieval of sunken and drifted logs located in Barangay Sta. Teresita, Municipality of Dumarán, Province of Palawan brought by the onslaught of Typhoon Odette in December 2021.

Despite nearly two (2) years since the typhoon entered the Philippine area of responsibility and the partial lifting of the moratorium on the issuance of Wood Recovery Permit as espoused by the Memorandum of then DENR Secretary, Jim O. Sampilna dated March 2, 2022, wherein typhoon Odette-affected areas were given the chance to retrieve the uprooted and typhoon-damaged trees within forest lands and private lands and be issued with WRP with a maximum validity of one (1) year depending on volume, the applicant has not yet fully exhausted its wood recovery efforts, thus, this extension appeal.

While the Memorandum explicitly orders that no issuance of new WRP beyond the prescribed period shall be undertaken by the concerned DENR officials, we will still be referring the matter to you, for further evaluation and assessment of the request taking into consideration the condition of the damaged trees being requested for retrieval.

Kindly submit your categorical recommendation on the matter and apprise the applicant of the status of their request accordingly.

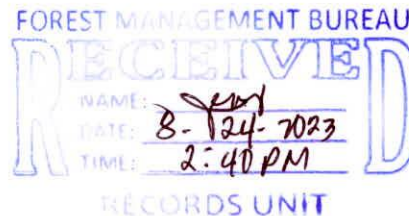

We pray for your kind consideration on the matter and look forward that our request will be grant by your good office.

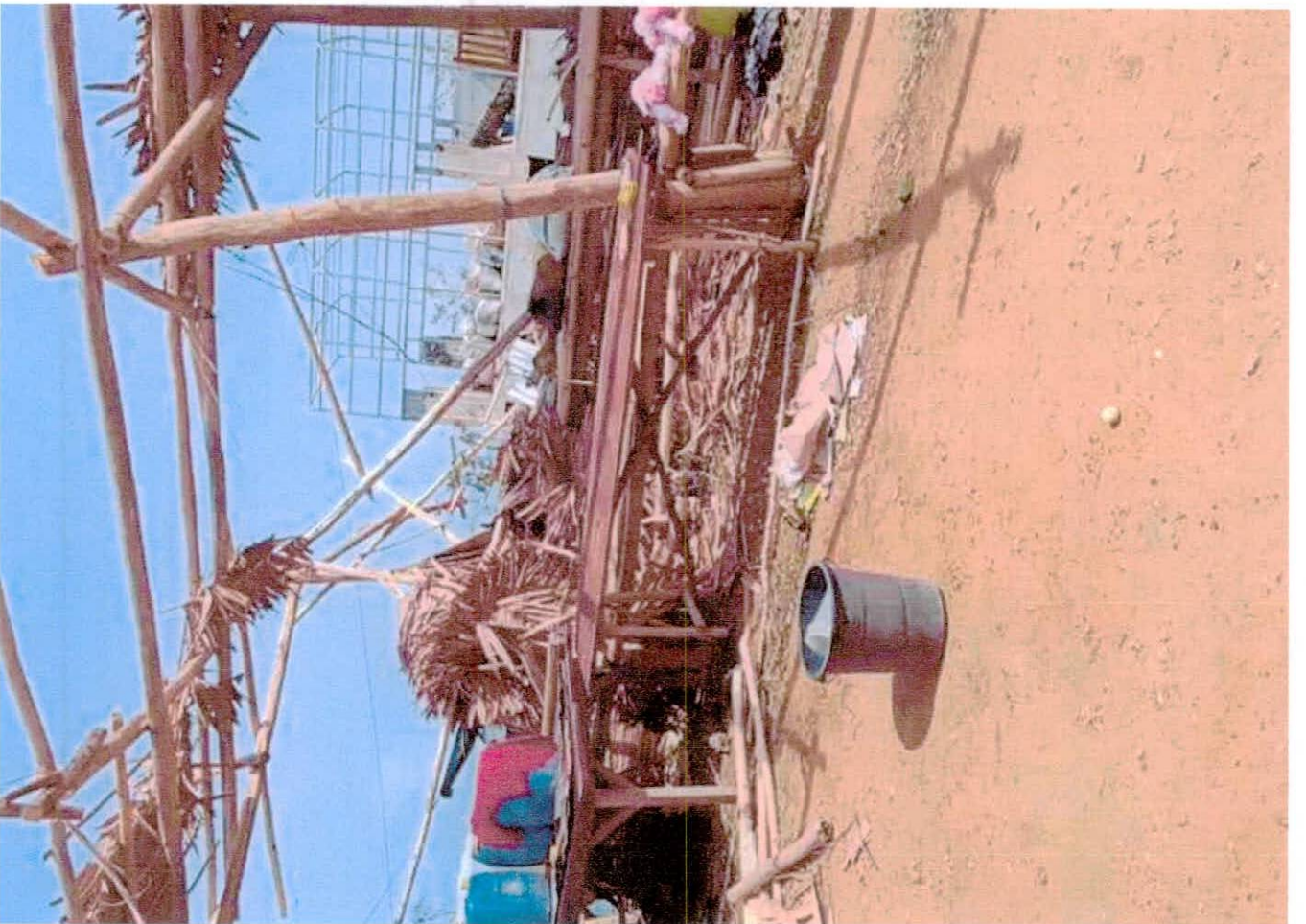

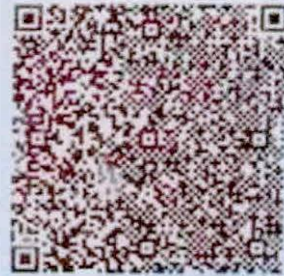

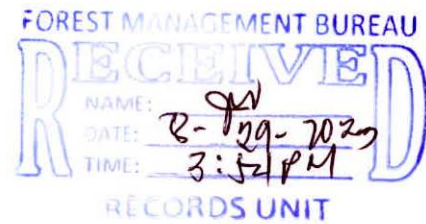
