**RESOLUTION GRANTING THE REQUEST OF CITY PACIFIC GROUP INC TO ADD  
MGB CONSTRUCTION AND TRADING AS A JOINT VENTURE PARTNER FOR THE  
CONDUCT OF ITS PROPOSED RIVER DREDGING AND DE-SILTING OF THE AMNAY  
RIVER**

**WHEREAS**, the Constitution mandates the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

**WHEREAS**, Executive Order No. 292 s. 1987, otherwise known as the "Administrative Code of 1987" stipulates that the State shall ensure, for the benefit of the Filipino people, the full exploration and development as well as the judicious disposition, utilization, management, renewal, and conservation of the country's forest, mineral, land, waters, fisheries, wildlife, off-shore areas and other natural resources, consistent with the necessity of maintaining sound ecological balance and protecting and enhancing the quality of the environment and the objective of making the exploration, development, and utilization of such natural resources equitably accessible to the different segments of the present as well as future generations;

**WHEREAS**, pursuant to DENR DAO 2020-12, the Provincial Governor is designated as the Chairman of the Inter-Agency Committee (IAC) composed of DENR-Region 4B, EMB-Region 4B, MGB-Region 4B and DPWH Region 4B with the role of promulgating policies that would enhance the implementation of existing laws and guidelines on river restoration and dredging activities;

**WHEREAS**, in its Resolution No 6, the IAC approved the creation of the PGO Secretariat and has issued the technical and financial requirements for proponents to be qualified to participate in the restoration and rehabilitation of the identified flood causing rivers in the Province.

**WHEREAS**, the PGO Secretariat has issued a report on the status of the progress of documentation of the various proponents as of December 15, 2022 and has presented this to the IAC.

**WHEREAS**, the PGO has called the attention of proponents for the seemingly slow progress in complying with the requirements of the IAC.

**WHEREAS**, a number of proponents have experienced delays in complying with the financial and technical requirements.

**WHEREAS**, on February 23, 2023, City Pacific Group Inc, has filed a request with the PGO to add MGB Construction and Trading as a Joint Venture Partner for the conduct of its proposed river dredging and de-silting of the Amnay River in order to comply with the technical requirements as set forth by the IAC.

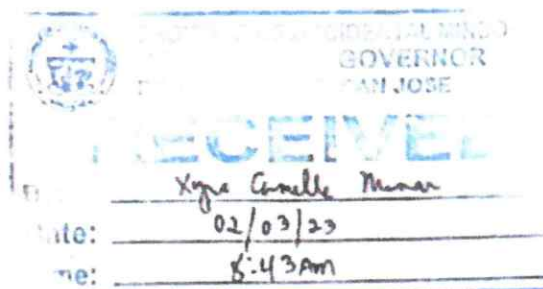
