Noble, duly seconded by other members present, **BE IT RESOLVED**, as this Body hereby resolves in its meeting duly assembled on July 15, 2021, *"to exclude Lumintao River from the list of rivers for the dredging activities in the Province of Occidental Mindoro to be evaluated by the IAC in view of the DPWH Dredging Clearance and approved dredging plan issued to Bluemax Tradelink, Inc. in 2018 or prior to the issuance of DENR Administrative Order No. 2020-12. Also, Bluemax Tradelink Inc. has already been undertaking desilting activities in Lumintao River, Rizal, Occidental Mindoro and has a Memorandum of Agreement with the Provincial Government of Occidental Mindoro prior to the issuance of the above Administrative Order. Therefore, Bluemax Tradelink, Inc. may commence with the implementation of a large scale dredging operation in Lumintao River, subject to the issuance of an Environmental Compliance Certificate (ECC) by the EMB Central Office."*







**RESOLUTION RECOMMENDING PROPONENTS THAT ARE FINANCIALLY
QUALIFIED TO UNDERTAKE DREDGING ACTIVITIES IN THE HEAVILY-SILTED
RIVER CHANNELS WITHIN THE PROVINCE OF OCCIDENTAL MINDORO**

RESOLUTION NO. 1, SERIES OF 2021

WHEREAS, the Department of Environment and Natural Resources (DENR) issued DENR Administrative Order No. 2020-12 with the subject of Rationalizing Dredging Activities in Heavily-Silted River Channels within the Province of Occidental Mindoro pursuant to the DENR-DPWH-DILG-DOTC Joint Memorandum Circular No. 1 Series of 2019;

WHEREAS, Section 2 Title II of the above-mentioned Administrative Order states that "applicants must possess the financial capacity prescribed by the Inter-Agency Committee to undertake dredging operations";

WHEREAS, the Inter-Agency Committee issued the following minimum financial capability as one of the requirements that a proponent should possess in order to qualify to undertake dredging activities;

1. Company Profile/ Brochures;
2. SEC Certificate of Registration and Articles of Incorporation;
3. 2020 General Information Sheet:
 - a. For LARGE RIVERS/ 3rd Order Stream – ONE BILLION PESOS (Php 1,000,000,000.00) minimum Authorized Capital Stock, 25% of which needs to be Subscribed and Paid-up;
 - b. For MEDIUM RIVERS/ 2nd Order Stream – THREE HUNDRED MILLION PESOS (Php 300,000,000.00) minimum Authorized Capital Stock, 25% of which needs to be Subscribed and Paid-up;
 - c. For SMALL RIVERS/ 1st Order Stream – ONE HUNDRED MILLION PESOS (Php 100,000,000.00) minimum Authorized Capital Stock, 25% of which needs to be Subscribed and Paid-up;
4. In case of Joint Venture, Partnership or Consortium, one of the members must possess the above prescribed FINANCIAL CAPABILITY;
5. The Corporation, Joint Venture, Partnership or Consortium must be 100% Filipino-owned; and
6. Notarized Joint Venture, Partnership or Consortium Agreement;

WHEREAS, the abovementioned Letters of Intent and supporting documents were turned-over by the Secretariat of IAC to DPWH Regional Office IV-B Technical Working Group for Dredging Activities (TWG) on 07 May 2021, to undergo review and evaluation;

WHEREAS, upon careful review and evaluation of the TWG of the financial documents of the above-listed proponents, it was found that the following possessed the minimum financial capacity set by the IAC to undertake dredging activities in the Province of Occidental Mindoro:

- a. **JV of Melekon Contractors, Inc. and Silverwolves Construction Corp.**, whose Authorized Capital is One Billion Pesos (Php 1,000,000,000.00), Subscribed Capital is Three Hundred Seventeen Million Pesos (Php 317,000,000.00) and Paid-up Capital is Two Hundred Fifty Million Pesos (Php 250,000,000.00), thus, possesses the financial capacity to undertake **Large Rivers**;
- b. **Pacific Concrete Products, Inc.**, whose Authorized Capital is One Billion Pesos (Php 1,000,000,000.00), Subscribed Capital is Three Hundred Forty-Five Million Pesos (Php 345,000,000.00) and Paid-up Capital is Three Hundred Forty-Five Million Pesos (Php 345,000,000.00), thus, possesses the financial capacity to undertake **Large Rivers**;
- c. **JV of PERRC Construction and Development Corporation and Melekon Contractos, Inc.**, whose Authorized Capital is One Billion Pesos (Php 1,000,000,000.00), Subscribed Capital is Three Hundred Million Pesos (Php 300,000,000.00) and Paid-up Capital is Three Hundred Million Pesos (Php 300,000,000.00), thus, possesses the financial capacity to undertake **Large Rivers**;
- d. **JV of Groundport, Inc. and Royal Crown Monarch Construction & Supplies Corporation, Tarlac 3-G Construction and Development Corporation, R.R. Ricafort Construction and Supplies**, whose Authorized Capital is Three Hundred Million Pesos (Php 300,000,000.00), Subscribed Capital is Two Hundred Twenty-Five Million Pesos (Php 225,000,000.00) and Paid-up Capital is Two Hundred Twenty-Five Million Pesos (Php 225,000,000.00), thus, possesses the financial capacity to undertake **Medium Rivers**;
- e. **Seagate Engineering and Buildsystems**, a Sole Proprietor, whose Capitalization is Three Hundred Forty Million One Hundred Eleven Thousand Eight Hundred Ninety-

Seven Pesos (Php 340,111,897), thus, possesses the financial capacity to undertake **Medium Rivers;**

- f. **Asia King Dragon Construction and Development Corporation**, whose Authorized Capital is One Billion Pesos (Php 1,000,000,000.00), Subscribed Capital is Two Hundred Fifty Million Pesos (Php 250,000,000.00) and Paid-up Capital is Sixty-Two Million Five Hundred Thousand Pesos (Php 62,500,000.00), thus, possesses the financial capacity to undertake **Small Rivers;**
- g. **Bird's Nest Resources Corporation**, whose Authorized Capital is One Hundred (Php 100,000,000.00), Subscribed Capital is Twenty Five Million Pesos (Php 25,000,000.00) and Paid-up Capital is Twenty Five Million Pesos (Php 25,000,000.00), thus, possesses the financial capacity to undertake **Small Rivers;**
- h. **JV of Hyspecz Builders and Ar-Vi Agro Industrial Corporation and B.C. Cuerpo Construction Corporation**, whose Authorized Capital, Subscribed Capital and Paid-up Capital are One Hundred Fifty-Five Million Pesos (Php 155,000,000.00), thus, possesses the financial capacity to undertake **Small Rivers;**

Laborte Builders thirty (30) days from receipt of notice to comply with the capitalization requirement set forth under IAC Resolution No. 1 Series of 2020 to qualify to undertake dredging operations in the province of Occidental Mindoro in accordance with DENR Administrative Order No. 2020-12."*

WHEREAS, in the IAC meeting held May 26, 2022, the IAC decided and resolved that a company with financial and technical capacity to undertake dredging operations in large rivers based on IAC Resolution No. 1 Series of 2020 may have a joint venture with one (1) applicant to undertake dredging activities in a large river and with another applicant to undertake dredging activities in either medium or small river only.

Gadiano, duly seconded by other members present, **BE IT RESOLVED**, as this Body hereby resolves that, *"a company which has the financial and technical capacity to undertake dredging operations in large rivers based on IAC Resolution No. 1 Series of 2020 may have a joint venture with one (1) applicant to undertake dredging activities in a large river and may have a joint venture with another applicant to undertake dredging activities in either medium or small river only."*

**RESOLUTION AUTHORIZING THE RIVER MOUTH DEPOSIT REMOVAL
WITHIN THE HEAVILY-SILTED RIVER CHANNELS OF THE
PROVINCE OF OCCIDENTAL MINDORO**

WHEREAS, the Constitution mandates the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Executive Order No. 292, Series of 1987, otherwise known as the "Administrative Code of 1987", stipulates that the State shall ensure, for the benefit of the Filipino people, the full exploration and development as well as the judicious disposition, utilization, management, renewal, and conservation of the country's forest, mineral, land, waters, fisheries, wildlife, off-shore areas and other natural resources, consistent with the necessity of maintaining sound ecological balance and protecting and enhancing the quality of the environment and the objective of making the exploration, development, and utilization of such natural resources equitably accessible to the different segments of the present as well as future generations;

WHEREAS, under the General Power and Attributes of Local Government Units, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, pursuant to Republic Act No. 7942, otherwise known as the Philippine Mining Act of 1995, the State shall promote the rational exploration, development, utilization and conservation of all mineral resources in order to enhance national growth in a way that effectively safeguards the environment and protect the rights of affected communities;

WHEREAS, the Department of Public Works and Highways (DPWH), the Department of Environment and Natural Resources (DENR), the Department of Interior and Local Government (DILG), and the Department of Transportation (DOTr), entered into a Joint Memorandum Circular (JMC) No. 1, Series of 2019, which sets the guidelines on the Issuance of Clearance and/or Permit for Dredging within the Waterways or other Inland Bodies of Waters;

WHEREAS, pursuant to Section 5.4 of the aforesaid JMC, DENR Administrative Order (DAO) No. 2020-12, dated October 7, 2020, was issued in order to rationalize Dredging Activities in Heavily-Silted River Channels within the Province of Occidental Mindoro;

WHEREAS, Section 1, Title VII of the aforesaid said DAO provides the creation of an Inter-Agency Committee (IAC), the composition of which are as follows: (a) Governor of the Province of Occidental Mindoro; (b) Regional Executive Director of DENR MIMAROPA Region; (c) Regional Director of DPWH Regional Office IV-B; (d) Regional Director of Mines and Geosciences Bureau (MGB) MIMAROPA Region; and (e) Regional Director of Environmental Management Bureau (EMB) MIMAROPA Region;

WHEREAS, Section 2 (c), Title VII of the above-mentioned DAO states that the IAC has the power to propose policies and programs to rationalize the dredging operations;

WHEREAS, Section 4 of Title III of above-mentioned DAO provides for a prescribed dredging method wherein in order to restore the natural state and flow of the river and taking into consideration the essential role played by constant sand replenishment, dredging activities shall be initially conducted at the deltas of heavily-silted river channels with the objective of creating navigational channels and providing more depth for passage of dredging vessel/s to implement true flood control measures within the river dredging zones (RDZ);

WHEREAS, it has been a common knowledge that the cause of perennial flooding in the Province of Occidental Mindoro, particularly in the adjacent areas of the river basin is the voluminous deposits of silt, sand, gravel and other debris in the rivers and rivers deltas in the province;

WHEREAS, year after year, the massive flooding in the areas and communities of the adjoining rivers in the province have caused tremendous damage to crops, properties and sources of livelihood and even resulted to loss of lives;

WHEREAS, under the R.A. 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010 (PDRRM Act of 2010), provides the creation of Local (Provincial) Disaster Risk Reduction and Management Office (PDRRMO) with a function of identifying, assessing and managing the hazards vulnerabilities and risks that may occur in their locality, to include implementing cost-effective risk reduction measures/strategies to address the said hazards;

WHEREAS, the PDRRMO may develop, strengthen and operationalize mechanisms for partnership or networking with the Private Sector, Civil Society Organizations (CSO) and Volunteer Groups for the effective disaster risk reduction and management in the province;

WHEREAS, considering that it is already rainy season and in view of the urgency of putting into place disaster reduction and mitigating measures on the devastating effects of massive flooding in the province, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) of the province convened on August 5, 2022 and issued Resolution No. 3 series of 2022 entitled "**RESOLUTION REQUESTING HON. ANTONIA 'TONI' YULO-LOYZAGA, SECRETARY OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) AND HON. MANUEL M. BONOAN, SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO LAUNCH RIVER WATERWAYS CLEAN-UP TO CLEAR THE IDENTIFIED RIVER**

WHEREAS, the River Restoration through Dredging Activities under Section 5.4 of JMC No. 1, Series of 2019, does not cover Industrial Sand and Gravel (ISAG) or Commercial Sand and Gravel (CSAG) regimes since the activity to be undertaken is dredging and not quarrying. However, this will not preclude the entitlement of the Province of Occidental Mindoro to the share from the commercial disposal of the dredged material in addition to the undertaking of the permit holder to restore the river thru dredging;

WHEREAS, the Local Government Units are entitled to their equitable share derived from the utilization and development of the national wealth within their respective areas;

WHEREAS, disposal of dredged or extracted materials under this Order shall be governed by the principle according to which the government expects a reasonable return for its utilization, while holders of dredging clearance expect a reasonable return for its dredging operations while restoring the river to its original state;

WHEREAS, the Authority to remove the deposits along the river mouths and enhance the adjacent areas in the identified rivers of the province shall be vested upon the Inter-Agency Committee (IAC) on the Restoration of the Occidental Mindoro Rivers and its Tributaries considering that the DPWH and MGB does not exercise jurisdiction over the river mouths towards the sea;

NOW, THEREFORE, by unanimous decision of the members present, the Inter-Agency Committee on the Restoration of the Occidental Mindoro Rivers and its Tributaries, hereby **RESOLVE**, as it is hereby **RESOLVED** to allow the LGU-Province through the Office of the Governor to issue the Notice to Proceed and the corresponding permits to qualified applicant who will undertake the River Mouth Deposit Removal Project upon compliance to the following:

1. Submission of River Delta Clearing and Shoreline Enhancement Plan that shall define the program of activities in removing the river mouth deposits or clearing the river delta to restore the natural state and flow of the river thereby creating navigational channels and providing more depth for passage of dredging vessel/s to implement true flood control measures within the river dredging zones. The plan shall include information, such as but not limited to the following: maximum depth and width of the clearing of mouth deposit activity; maximum distance from the shoreline; volume of material to be removed; duration of activity; bathymetric and marine studies; baseline environmental study; and other necessary information as may be required and deem necessary by the IAC;
2. Environmental Compliance Certificate for the River Mouth Deposit Removal Project;
3. Signed Memorandum of Agreement between DENR MIMAROPA and the Proponent witnessed by the MGB MIMAROPA, EMB MIMAROPA and DPWH pursuant to DAO 2020-12; and
4. Payment of the necessary fees, charges and taxes.

RESOLVED FURTHER the DPWH Regional Office IV-B, upon the request of the IAC, is hereby authorized to initially review the River Delta Clearing and Shoreline Enhancement

 - b. Inspect and/or evaluate the equipment, vessels, and machineries declared/pledged by applicants for the dredging activities and determine that the same are qualified, available, and are in good working conditions;
 - c. Monitor/check if the equipment, vessel, or machineries on-site conforms with the equipment declared/pledged for the activity and make recommendations, if necessary, to suspend/revoke the operation

should the said equipment, vessel, or machineries are not found on the site or the same are not in good working condition;


- d. Make appropriate recommendations to the committee whether an applicant is technically qualified or not; and

**RESOLUTION CREATING PROCESS FLOW FOR THE APPLICATIONS FOR
RIVER RESTORATION THROUGH DREDGING ACTIVITIES IN THE HEAVILY SILTED
RIVER CHANNELS AT THE PROVINCE OF OCCIDENTAL MINDORO**

WHEREAS, the Department of Public Works and Highways (DPWH), Department of Environment and Natural Resources (DENR), Department of Interior and Local Government (DILG), and Department of Transportation (DOTr), entered into a Joint Memorandum Circular (JMC) No. 1, Series of 2019 which sets the guidelines on the Issuance of Clearance and/or Permit for Dredging within the Waterways or other Inland Bodies of Waters;

NOW, THEREFORE, by unanimous decision of the members present, the Inter-Agency Committee on the Restoration of the Occidental Mindoro Rivers and its Tributaries, hereby **RESOLVE**, as it is hereby **RESOLVED** to create the following General Process Flow as guide for applicants who intends to conduct River Restoration through Dredging Activities at the Heavily-Silted Rivers of the Province of Occidental Mindoro, to wit:

1. The Inter-Agency Committee will issue a Resolution Setting the Minimum Financial and Technical Requirements that an applicant must possess for them to be allowed to conduct River Restoration through Dredging Activities at the Heavily-Silted Rivers of the Province of Occidental Mindoro;
 2. Mindoro Occidental Provincial Government to Publish the Minimum Financial and Technical Requirements as well as their invitations to prospective applicants to conduct River Restoration through Dredging Activities at the Heavily-Silted Rivers of the Province of Occidental Mindoro;
 3. Applicant to submit to the Provincial Office their Intent to Conduct Dredging Activities together with their Technical and Financial Documents;

4. The Financial and Technical Working Groups to review of applicant's qualifications based on the Minimum Requirements set by IAC, wherein applicants should both pass the financial and technical Requirements;
5. Financial and Technical Working Groups to submit finding to the IAC for confirmation/approval;
6. In case of failure, applicant(s) may move for Reconsideration before the IAC which shall resolve the same on the immediately preceding IAC Meeting;
7. If passed, applicant shall be endorsed to DPWH Regional Office IV-B (DPWH R4B) for the Dredging Master Plan (DMP);
8. DMP, including all supporting documents, submitted to DPWH R4B shall be initially checked by the Planning and Design Division (PDD) based on relevant DPWH Department Orders and if found to be in order, shall be endorsed and submitted to the Bureau of Design (BOD) for review and recommending approval. Then subject to approval and signing of the Undersecretary for Technical Services;
9. Signatories for the DMP shall be as follows:

10. Applicants then shall secure the necessary environmental clearances (e.g. ECC) from the Department of Environment and Natural Resources (DENR), Environmental Management Bureau (EMB), or Mines and Geosciences Bureau (MGB);
11. After presenting the necessary environmental clearances, applicants shall secure the required Dredging Permit/Clearance from DPWH R4B which shall only be valid within five (5) years or as specified in the Environmental Compliance Certificate (ECC) effectivity. A new application shall be filed should the proponent request for an extension;
12. Applicant then shall secure other Permit(s)/Clearance(s) from other relevant offices/agencies and submit other Certification(s) in compliance with other requirements of the above mentioned JMC and DAO;
13. Applicants shall also pay of the required Bond to the Province as well other fees required by other relevant offices/agencies;
14. Applicant and DENR-MIMAROPA to execute and enter into a Memorandum of Agreement (MOA);

15. The Provincial Office, thru the Governor, to issue Notice to Proceed (NTP) in favor of the Applicant; and
16. Monitoring of the Dredging Operations.

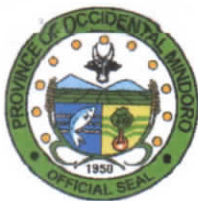

RESOLUTION NO. 22 Series of 2022

RESOLUTION AUTHORIZING THE GOVERNOR OF OCCIDENTAL MINDORO AS CHAIRMAN OF THE INTER-AGENCY COMMITTEE TO WAIVE RIVER ASSIGNMENTS OF INACTIVE PROPONENTS AFTER DUE NOTICE

WHEREAS, Joint Memorandum Circular No. 01, Series of 2019 (JMC 2019-01) was issued for the information and guidance of a qualified person who wish to apply for a clearance/permit to dredge within rivers, river deltas, and other inland bodies of water. It prescribes the procedure in the application for the said clearance and/or permit and sets the standard and technical requirements in the planning, design, and implementation of dredging activities defined in the following sections;

WHEREAS, pursuant to Section 5.4 of JMC 2019-01, DENR River Restoration through dredging activities in heavily silted river channels, including disposal of extracted materials, shall be covered by a separate Order to be issued by the DENR in coordination with DPWH. Issuance of dredging permit/clearance by the DPWH shall be based on the Detailed Engineering Design Plans;

WHEREAS, pursuant to Section 2, Title II of DENR DAO 2020-12, applicants must possess the financial capacity prescribed by the IAC to undertake dredging operations;

WHEREAS, pursuant to Section 3, Title II of DENR DAO 2020-12, only applicants capable of implementing large-scale activities for flood mitigation or prevention purposes in the heavily-silted river channels within the Province of Occidental Mindoro, based on their technical knowledge and verifiable previous track record conducting such activities, as properly vetted, duly certified and approved by the appropriate DENR and DPWH offices;

WHEREAS, pursuant to Paragraph C, Section 4, Title II of DENR DAO 2020-12, applicants shall secure the required clearances from the appropriate government office including a certification of no pending case relating to compliance with existing environmental laws, rules, and regulations, and an undertaking that it will never be involved in such;

WHEREAS, in addition to the requirements mandated by DENR DAO 2020-12, applicants shall also secure other permits and clearances from other concerned government offices and agencies;

WHEREAS, pursuant to Sections 1 and 2, Title VII of the Department of Environment and Natural Resources Administrative Order No. 2020-12 (DENR DAO 2020-12), the Provincial Governor of Occidental Mindoro is designated as the Chairman of the Inter-Agency Committee (IAC Committee), composed of DENR-Region 4B, EMB-Region 4B, MGB-Region 4B, and DPWH-Region 4B, with the role of promulgating policies that would enhance the implementation of existing laws and guidelines on river restoration and dredging activities;

WHEREAS, it appears that there are qualified proponents, which were already assigned rivers for restoration, that have yet to provide the necessary requirements despite due and several notices;

WHEREAS, the restoration of the Occidental Mindoro rivers and tributaries is imbued with public interest because the voluminous deposits of silt, sand, and other debris in these river channels cause perennial flooding to adjacent areas;

WHEREAS, the inaction of qualified proponents consequently and unduly delays the much-needed restoration of rivers that could effectively address the perennial flooding in Occidental Mindoro;

WHEREAS, the people of Occidental Mindoro and public interest call for a policy that could address the inaction of qualified proponents;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY DONE, the Provincial Governor of Occidental Mindoro as IAC Chairman, upon confirmation of DENR-Region 4B, EMB-Region 4B, MGB-Region 4B, or DPWH-Region 4B (hereinafter referred to as "concerned agency") that a certain qualified proponent has been inactive in the completion and/or submission of requirements (hereinafter referred to as "inactive qualified proponent"), has the authority to waive the river assignment thereof after due notice;

BE IT FURTHER RESOLVED, that DENR-Region 4B, EMB-Region 4B, MGB-Region 4B, and/or DPWH-Region 4B shall endorse a *Confirmation Letter* to the IAC Chairman upon finding that a certain qualified proponent has yet to complete and/or submit the necessary requirements despite due notice; Provided, However, that a qualified proponent has thirty (30) days from notice from the concerned agency to complete and/or submit the necessary requirements;

BE IT FURTHER RESOLVED, that upon receipt of the *Confirmation Letter*, and within five (5) days therefrom, the IAC Chairman shall send a *Final Notice* to the inactive qualified proponent through 1) personal service, 2) registered mail, and 3) electronic mail; Provided, However, that the concerned agency and the IAC Secretariat be copy furnished thereof; Provided, Further, that upon the service of the *Final Notice* through personal service, registered mail, and electronic mail, respectively, the IAC Secretariat shall send a text message to the inactive qualified proponent, informing the latter of such personal service, registered mail, or electronic mail;

BE IT FURTHER RESOLVED, that the inactive qualified proponent has thirty (30) days from receipt of the *Final Notice* that was served through personal service, registered mail, or electronic mail, whichever is earlier, to complete and/or submit the necessary requirements to the concerned agency;

BE IT FURTHER RESOLVED, that should the inactive qualified proponent fail to complete and/or submit the necessary requirements to the concerned agency within thirty (30) days from receipt of the *Final Notice* that was served through personal service, registered mail, or electronic mail, whichever is earlier, and upon confirmation of the concerned agency of such failure, the IAC Chairman shall waive the river assignment/s of the inactive qualified proponent;

BE IT FURTHER RESOLVED, that this *Resolution* shall apply prospectively upon approval of the IAC Committee; Provided, However, that the prospective application of this *Resolution* shall apply to new and existing qualified proponents; Provided, Further, that existing qualified proponents prior to the approval of this *Resolution* shall be given due notice hereof; Provided, Finally, that existing qualified proponents prior to the approval of this *Resolution* that have pending requirements for completion and/or submission have 30 days from receipt of written notice from the concerned agency to complete and/or submit the same before the concerned agency could endorse a *Confirmation Letter*, if necessary, to the IAC Chairman;

BE IT FURTHER RESOLVED, that all new and existing qualified proponents shall provide the IAC Committee their preferred 1) email addresses, 2) business addresses, and 3) other pertinent contact information, to which the *Final Notice* shall be served through personal service, registered mail, or electronic mail, as the case may be; Provided, However, that all new and existing qualified proponents shall likewise provide the IAC Committee their preferred mobile numbers, to which the IAC Secretariat shall send a text message of the fact of service of *Final Notice* through personal service, registered mail, and electronic mail, respectively;

RESOLVED FINALLY, that all waived river assignments by virtue of this *Resolution* shall be open for reassignment to other qualified proponents; Provided, However, that reassignment shall follow existing rules and regulations on the assignment of rivers.
