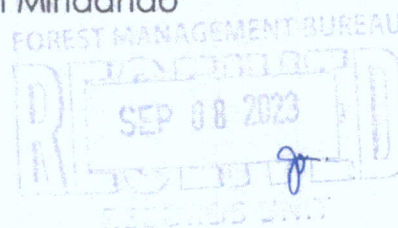

The Department of Agrarian Reform (DAR) in collaboration with the World Bank (WB) initiated and implemented Project SPLIT to facilitate and expedite the issuance of individual E-Titles to qualified beneficiaries. This project is under a Loan Agreement between the Government of the Philippines (GOP) and the WB. Its goal is to enhance land tenure security and strengthen property rights for Agrarian Reform Beneficiaries (ARBs) across 78 provinces spanning 15 regions nationwide.
