The DENR Strategic Communication and Initiatives Service (SCIS) through the Knowledge and Information System Service (KISS) has renewed a one (1) year subscription of the Adobe Creative Cloud for Teams (CCT) to support central and regional offices in the production of IEC materials such as videos, print materials/ publications, and web materials.

The Adobe CCT subscription package includes all the latest products of Adobe for photography and design, video and audio production, and web and mobile development.

In this regard, and for us to process the deployment of Adobe CCT accounts to all DENR regional offices, may we request that you **update your designated Adobe CCT account holder** listed in the attached table. **Please use the official email of the office** (not personal email). Adobe applications can be installed in 3 computers/laptops but cannot be used simultaneously (one application at a time only).

Please be reminded also that the designated Adobe account holder must be a permanent personnel from the Regional Strategic Communication and Initiatives Group and responsible for the content management of the Regional External DENR Web Portal (REDWP)/Regional website.

We would appreciate receiving the updated name of your account holder, position, official office email address, and mobile number on or before September 20, 2023 as the license commenced on September 07, 2023. This will also allow you to immediately start using the new Adobe CCT for all your IEC production needs.
