Respectfully submitted hereunder are our comments based on the review of the submitted shapefiles that can be accessed thru https://tinyurl.com/2023-MIMAROPA-PIA:

- All reported figures matched the calculated statistics based on the submitted shapefiles (refer to Table 1);
- The submitted shapefiles contain an overlap with previous submissions of accomplishments on PIA (see attachment). The areas that overlaps are site codes R4B 2019-00007 and R4B-2023-00009 of about 0.098 hectare; and
- The submitted shapefiles followed the format as described in FMB Technical Bulletin 5A. We request for the resubmission of polygon shapefiles that follow the prescribed attribute format as part of the 11 Forestry Spatial Dataset (FSD) Committed for the DENR Control Map.
