DETAILS OF DOCUMENT <i>Detalye ng dokumento</i>	This pertains to the complaint of Mr. Danilo Esteves against PAMO of Occidental Mindoro for its alleged delaying of the administrative hearing involving the confiscation of their fishing boats as they were apprehended fishing within the Apo Reef Natural Park. Accordingly, the said confiscation adversely affected their livelihood, their financial capabilities, and their moral status in their barangay.

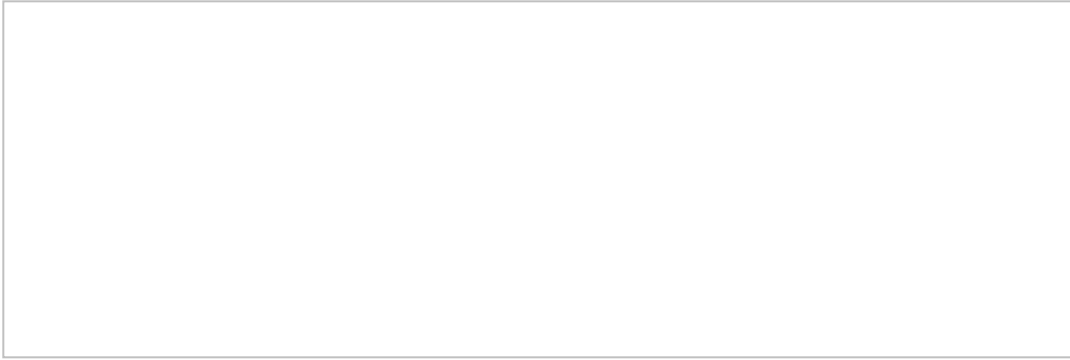
