Cruz; Gasan Port terminal in Gasan and Barangay Masiga, Gasan Airport respectively. This is in compliance with PENRO Special Order No. 023 dated January 25, 2023.

As per report, the Wildlife Traffic Monitoring Unit (WTMU) conducted continuous monitoring and surveillance together with the personnel of other Government Agencies (OGAs) such as Philippine Ports Authority (PPA), Philippine National Police, Philippine Coast Guard, PNP-Maritime Police. They are requested for the collaborative effort to monitor the possible movement of undocumented wildlife and forest products within and outside of the province of Marinduque. During the monitoring, there were no illegal transport of wildlife and forest products detected by the team during the month of September CY 2023.

Further, the Marinduque Airport located in Barangay Masiga, Gasan, Marinduque is still closed for domestic flights, however, it is open for pilot training.

Furthermore, IEC materials such as flyers of Republic Act No. 9147 "Wildlife Conservation and Protection Act" and other DENR forestry laws, rules and regulations were also disseminated as part of public awareness campaign.

Please be informed that personnel of Monitoring and Enforcement Section are continuously conducting monitoring of five (5) ports located in Barangay Buyabod, Sta. Cruz, Barangay Balanacan, Mogpog, Brgy. Dos, Gasan and Brgy. Cawit, Boac and one (1) airport in Barangay Masiga, Gasan which is still closed for domestic flights, however, it is open for pilot training.

In addition, the team coordinated with other Government Agencies (OGAs) particularly the Philippine National Police, PNP-Maritime, Philippine Port Authority (PPA), Philippine Coast Guard and LGUs of Barangay requested for the collaborative effort to monitor the possible movement of undocumented wildlife and forest products within and outside of the province of Marinduque.

During the monitoring, there were no illegal transport of wildlife and forest products detected by the team during the month of September CY 2023.

Furthermore, continuously conducting Information, Education and Communication Campaign through dissemination of informational materials such as flyers of Republic Act No. 9147 "Wildlife Conservation and Protection Act" and other DENR forestry laws, rules and regulations as part of public awareness campaign.




