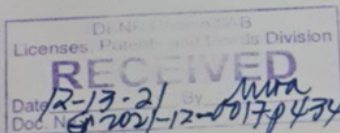

This has reference to your Memorandum for the Secretary dated 19 October 2021, attention to the Director, Forest Management Bureau regarding the request for a Provisional Agreement under DAO 2021-27 of Mr. Alexander B. Carlos, President of King Livestock Ranches and Nature Farms Corp. (KLRNFC). The said request for Provisional Agreement (PA) is related to their application for Forest Land Grazing Management Agreement (FLGMA) covering 1,400 hectares of land within Busuanga Pasture Reserve (BPR), pending the submission of Free and Prior Informed Consent (FPIC) from the National Commission on Indigenous Peoples (NCIP).

In line with the said application, kindly be informed that their application for Forest Land Grazing Management Agreement (FLGMA) complements the primary purpose of the BPR, which is for pasture reserve. However, please be apprised that a portion of the applied area overlaps with those covered by the existing Memoranda of Agreement (MOA) with the Department of Agriculture – Bureau of Animal Industry (DA-BAI), and the Department of Transportation – Civil Aviation Authority of the Philippines (DOT-CAAP). Moreover, a portion of the applied area also overlaps with the requested area for the establishment of a training camp of the Department of National Defense-Philippine Navy (DND-PN) subject to review by the Office of the Secretary. Copies of maps of the aforementioned overlapped areas are attached for reference.

Be informed that, Memorandum dated 17 September 2021 with a subject "Issuance of Provisional Agreement Pursuant to DAO 2021-27" issued by the Undersecretary for Field Operations & Environment, the RED concerned is authorized to issue a Provisional Agreement (PA) with a validity of two (2) years, in order to provide the applicant ample time to secure the corresponding Certification Precondition (CP) and/or Certificate of Non-Overlap (CNO) from the NCIP (Copy hereto attached).
