RE: Request for Boundary and Cadastral Maps of Abra de Ilog, Occidental Mindoro, and the Municipalities of Puerto Galera, Baco, and San Teodoro, Oriental Mindoro

Warm Felicitations!

Our company, **Mainstream Renewable Power Philippines (MRP)**, is in the process of being awarded a **Wind Energy Service Contract (WESC)** to exclusively study and develop an area straddling the Municipality of Abra de Ilog in Occidental Mindoro, and the Municipalities of Puerto Galera, Baco and San Teodoro in Oriental Mindoro for a potential onshore wind energy project.

We intend to conduct wind studies, lidar and topographic surveys to determine the viability of the said area for a possible wind energy project.

Before we can conduct these studies, MRP need to first determine the status and classification of the service area that will be awarded to us by the DOE. These include the land classification, boundaries of the municipalities and the barangays, and to identify any private lands around the service area.

In line with this, may we request from the Surveys and Mapping Division (SMD) **digital or soft copies** of the **latest barangay and political boundary maps** of the following municipalities:

1. Abra de Ilog, Occidental Mindoro
2. Puerto Galera, Oriental Mindoro
3. Baco, Oriental Mindoro
4. San Teodoro, Oriental Mindoro

We would also like to request for digital copies of the different cadastral maps covering the same four (4) municipalities.

Attached is a map of the service area to be awarded and its vicinity, with a request for certification from DENR on the land classification in the areas covered. We also have attached the coordinates, and a shapefile of the area for your reference and perusal.


