Dear Ms. Ibarra:

This pertains to your undated letter sent thru LBC and was received by this office on July 30, 2024 regarding your claim to the parcel of land allegedly owned by your father – Hidalgo Villarosa located at Sitio Pulong Bagto, Barangay Balansay, Mamburao, Occidental Mindoro.

We would like to re-iterate in our previous letters addressed to you that since the land titles were already issued a long time ago, this office has no longer jurisdiction over it. A team from the Monitoring and Enforcement Division of DENR Regional Office conducted the ocular inspection and investigation and submitted their report with categorical recommendations that you have to file an adverse claim to a proper court if you believe that you are the lawful owner of the land covered by the land titles.

With regard to your complaint that some personnel of this office were involve in the illegal issuance of land titles, it is already your call if you want to file a complaint against them.

Hope we have answered your concern and thank you very much.

until I discovered this indent card dismissed Petra, All surprised PNR no name of Petra Cuz 1989 now you dismissed Petra 1976! Nobody answer even Espejo can't speak so many manipulation. From the beginning I start searching Tax Declaration Mun. Assessor, I asked why It was transferred to Petra no answer humus mo ng habalin yan ang sago t.

Second time I met Verdera again Mindoro repeat its not true it was sold to Petra all documents was with me including the map

I start communicate with CENRO heard what the application dialogue, they don't know we are the owner waiting. We just

listen cause the time Quebec told me I had no right
in this land, I can't fight with him cause the time
I had presented documents still I'm afraid with him
cause he's shouting.

So many anomalies happened like no tax No
not in Pulang Bagio but in Mamurao, I don't know all of
these

Question your office was able to dismissed Petra with no
reason impossible you can't locate your documents or something
wrong, I imagine PEHRO 1989, Petra Cruz dismissed 1996
no reason. All employees can't speak even Espejo, Time
I asked there should be answer at once but all surprise
no body speak I said. darakan ni nyo indecend to prove it
came from your office, what can you say with this Mr.
Santos or the anomalies comes out?"

I don't know why there was no investigation to Quebec
and Espejo, So many manipulation in your office.

Another question why CENRO allowed Osmena to enter
this land cause he's holding documents of my father, indeed
the map, why did CENRO did not notify us my family
inspite we had a letter to them about this land, About the
plan of Verdera same time awarded of his children, so what's
this all about.


I asked you Mr. Santos what can you say with this,
