Good day!

In line with the continuous capacity building program and activities to ensure effective implementation of the Biodiversity-Friendly Enterprise (BDFE) within protected areas and other conservation areas, the Biodiversity Management Bureau (BMB) is organizing an Orientation-Workshop on Social Preparation and Business Planning for BDFEs cum policy consultation and BDFE roadmapping on the following schedules and clusters:

Consistent with DAO 2021-13 or the guidelines on BDFE Development and Recognition, this year's learning event will focus on two (2) integral parts of Business Development, Social Preparation and Business Planning. Social preparation is important to help create an enabling environment for BDFE to thrive. Meanwhile, business planning will help determine how all assets of the POs will be utilized to achieve its goals and objectives. These activities are envisioned to help strengthen BDFE implementation and facilitation, as well as help facilitators and POs to sustainably utilize assets/resources.

The learning event primarily aims to orient and provide the PAMO Staff and/or BDFE facilitators the proper tools for community organizing, specifically social preparation, and the development of a BDFE Business Plan for their respective POs. The learning event will also be a venue for the consultation on relevant policy, and BDFE road mapping. For reference, we have attached a copy of the draft Memorandum as well as the draft DENR-SO with the tentative Program.
