Please be informed that the Regional Trial Court - 4th Judicial Region of Oriental Mindoro, Branch 40 has turned-over apprehended equipment used as object of evidence for **Criminal Case No. CR-18-14,029** for violation of RA 7942 otherwise known as the Philippine Mining Act of 1995 (Illegal Exploration).

- 6. Two (2) pieces solid metal shafting



AMENDED ORDER

When this case was called for presentation of evidence for the prosecution, all accused appeared in court. Atty. Jovelyn R. Hernandez-Miraples of the Public Attorney's Office, counsel de officio of all the accused and Public Prosecutor Catalino C. Atienza are likewise attendant in court.

During the hearing, the defense counsel manifested that all the accused had a change of heart and wish to change their original pleas of not guilty to a GUILTY plea.

Thereafter, the defense counsel manifested that she already conferred with all the accused, who waived the public reading of the Information and would enter a guilty plea. The court explained to all the accused, in the dialect known to them, the nature of the charge against them as well as the consequences of the waiver and all the accused confirmed that they fully understood and expressly consent thereto.

WHEREFORE, considering the plea of guilty of accused Marieta Cabardo Bia, Renz de Villa Mendoza, Albert Manrilla dela Torre, and Mark Michael Mangayan dela Torre to the crime charged, judgment is hereby rendered finding said accused guilty beyond reasonable doubt for violation of Section 102, RA 7942 and all the accused are sentenced to pay a fine of Php5,000.00 each.

Insofar as accused Renz de Villa Mendoza is concerned, considering that he is currently in detention for another crime, the penalty imposed upon him is with a corresponding subsidiary imprisonment in case of inability to pay the fine to be computed at the rate of Php570.00 per day, an amount equivalent to the highest minimum wage prevailing in the Philippines.
