May this message find you well. I feel compelled to bring to your attention a matter of concern regarding the business partnership between Meriam Ocampo and Mr. Mariano, the DENR CENRO Head, in Taytay Palawan.

Until now, Meriam Ocampo has been regarded as a commendable business partner. However, recent observations suggest a deviation from the principles of honesty and ethical conduct. It has come to our attention that Ms. Ocampo is involved in the sale of land at an exorbitant cost per square meter, lacking the necessary documentation, particularly a special land use certificate.

This raises serious questions about the governance surrounding such transactions. We find it perplexing that the government permits individuals, like Ms. Ocampo, to engage in unscrupulous and illicit activities, especially given her business relationship with Mr. Mariano and the rest of the DENR inspectors of the land.

Though these issues are on a gradual rise, these inspectors even permit this MERIAM to sell and resale illegal lumber coming from the nearby forest of this poor land Taytay. However, tolerated by the CENRO because the main reason was that Meriam Ocampo was a good business partner of Mr. Mariano.

We are concerned that this association is not only tolerated but also seemingly protected by Mr. Mariano and his team, who receive bonuses and gifts from the government. This protection further exacerbates the issues surrounding the unauthorized and questionable sale of land.

I kindly urge you to address this matter promptly to uphold the principles of transparency, integrity, and ethical conduct within our government. Your attention to this issue is greatly appreciated.
