Endorsed is the letter dated October 14, 2023 of Director Roberto P. Alabado III, Officer-In-Charge, Department of Tourism, MIMAROPA regarding receipt of an email complaint of Mr. Patrick Schuck citing his experience in Eco Sanctuaries in Nacpan Beach, El Nido, Palawan.

Accordingly, Mr. Schuck, a foreign tourist from California, USA raised his concern on the presence of All Terrain Vehicles (ATV)) on the beach in Nacpan which he considered a sensitive environment. Mr. Schuck claimed that the ATV 4-wheel "continually zoom up and down the beach making terrible noise and leave behind a stench from the exhaust."

Citing from the letter, Director Alabado requested support from our Office to look into the matter as it pertains to "possible environmental impact in a tourism destination such as Nacpan Beach in El Nido, Palawan" where beaches are known to be marine turtle nesting sites. Hence, the issue is referred to your Office as you have the expertise to assess, comment and recommend immediate action/s regarding issues on air and noise pollution.

Nevertheless, Mr. Schuck appreciated the wonder and peace Eco Sanctuaries has offered during his one (1) week stay at the Eco Sanctuaries and "believed that the beach can be an international destination."
