This is to acknowledge receipt of your Memorandum dated November 7, 2023 submitting the investigation report of CENRO Quezon on the alleged illegal cutting of trees and charcoal making activities over a parcel of land adjacent to the CBFM area of Maranan Uplanders Association (MUMA) Inc. in Brgy. Calategas, Narra, Palawan.

Based on the report, Mr. Luis Bucalos bought more or less one (1) hectare out of the 800 hectares awarded to MUMA through a kasunduan dated January 23, 2023. Accordingly, Mr. Bucalos agreed to stop the brushing/clearing and cutting activities within their claimed area.
