**SUBJECT : AUTHORIZING THE CONDUCT OF A PROVINCE-WIDE WORKSHOP OF THE INDIGENOUS POLITICAL STRUCTURE (IPS) REPRESENTATIVES FOR THE IP MANDATORY REPRESENTATIVE (IPMR) GUIDELINES: A JOINT ACTIVITY OF THE MINDORO BD CORRIDOR PROJECT AND NCIP- OCCIDENTAL MINDORO ON MAY 29 TO JUNE 1, 2023 IN OCCIDENTAL MINDORO**
