Each participant is required to pay registration fee in the amount of Seven Thousand Pesos (PhP 7, 000.00). Payment shall be deposited to Metrobank Savings Account No. 358-3-35813951-6, Davao, Matina Branch with account name "Geodetic Engineers of the Philippines Inc.

Relative to this, all participants are reminded that the convention fee is subject to the provisions of National Budget Circular No. 563 dated April 22, 2016, Section 3.2 to read as follows: " The registration or participation fee in said convention, seminar, etc. shall not exceed PhP2,000.00 per day for each participant." Any amount in excess of the prescribed rate shall be at the expense of the participant. Participating personnel is entitled to Four Thousand Pesos (PhP4,000.00) registration fee subject to availability of funds, accounting and auditing rules and regulations.
